SUBJECT Adopt a Resolution Establishing the Regular Council Meeting Dates for the

Months of January, July, and April 2026 and Confirm the 2026 Regular

Meeting Calendar

RECOMMENDATION

Adopt the resolution and confirm the 2026 calendar of regular Town Council meetings.

BACKGROUND

Per Fairfax Town Code Section 2.08.010, regular Town Council meetings are held on the first Wednesday of each month at 6:30 p.m. However, exceptions are allowed by resolution for the months of January and July due to holiday conflicts. In addition, meetings may be rescheduled to avoid conflicts with other significant events or holidays.

DISCUSSION

Staff recommend adjusting the 2026 meeting dates for January, April, and July due to the following scheduling considerations:

- January 21, 2026 (3rd Wednesday): Avoids conflicts with New Year's holiday-related scheduling and provides adequate time for agenda preparation and public noticing.
- **April 15, 2026 (3rd Wednesday)**: Avoids a scheduling conflict with the Jewish holiday of Passover, which begins at sundown on April 1, 2026 (the first Wednesday of the month).
- July 15, 2026 (3rd Wednesday): Avoids conflicts with the Independence Day holiday.

Scheduling meetings on the third Wednesday of the month avoids conflicts with Ross Valley Fire Board meetings, typically held on the second Wednesday of the month. All other monthly meetings will remain scheduled on the first Wednesday of each month.

The recommended **Town Council's 2026 regular meeting calendar** is as follows:

RESOLUTION 25-

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX ESTABLISHING ITS REGULAR MEETING DATES IN THE MONTHS OF JANUARY, APRIL, AND JULY IN CALENDAR YEAR 2026, AND CONFIRMING THE FULL 2026 REGULAR MEETING CALENDAR

WHEREAS, Town Council regular meetings are held on the first Wednesday of every month at 6:30 p.m. pursuant to Town Code Section 2.08.010; and

WHEREAS, Town Code Section 2.08.010 allows the dates of regular meetings in January and July to be modified by resolution of the Town Council due to holiday conflicts or other scheduling considerations; and

WHEREAS, the Town Council desires to adjust the regular meeting dates in January, April, and July 2026 to avoid conflicts with holidays or other events that impact attendance, staff preparation time, or community engagement; and

WHEREAS, the first Wednesday in January 2026 follows the New Year's holiday and would not allow sufficient time for agenda preparation and public noticing, and the third Wednesday of the month provides adequate time for preparation and avoids conflict; and

WHEREAS, the first Wednesday in April 2026 conflicts with the Jewish holiday of Passover, and rescheduling to the third Wednesday accommodates observance of this holiday; and

WHEREAS, the first Wednesday in July 2026 falls too close to the Independence Day holiday, and the third Wednesday avoids the associated scheduling issues; and

WHEREAS, these rescheduled meetings also avoid conflicts with regularly scheduled Ross Valley Fire Board meetings, which typically occur on the second Wednesday of the month;
