

RESOLUTION NO. 25-32

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF MARIN TO RENDER FULL SERVICES TO THE TOWN RELATING TO THE CONDUCT OF A SPECIAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 4, 2025 FOR THE SUBMISSION OF THE QUESTION OF THE RECALL OF CERTAIN OFFICERS

WHEREAS, by adoption of Resolution No. 25-30 on August 6, 2025, the Town Council has called and given notice of a Special Municipal Election to be held on Tuesday, November 4, 2025 in the Town of Fairfax, County of Marin, for the purpose of submitting the following questions regarding the recall of Councilmembers Lisel Blash and Stephanie Hellman:

Shall Lisel Blash be recalled (removed) from the office of Town Councilmember of the Town of Fairfax?	YES

WHEREAS, by adoption of this Resolution, the Town Council desires that the County of Marin render full services to the Town in connection with said Special Municipal Election; and

WHEREAS, all necessary expenses in performing these services shall be paid by the Town of Fairfax.

NOW, THEREFORE, THE TOWN COUNCIL OF THE TOWN OF FAIRFAX, CALIFORNIA, DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. Pursuant to the provisions of Section 10002 of the Elections Code of the State of California, this Town Council requests the Board of Supervisors of Marin County to permit the County Registrar of Voters/Election Department to render full election services to the Town of Fairfax. The full election services which the Town of Fairfax requests the Registrar of Voters/Election Department, or such other official as may be appropriate, to perform, and which such officer is hereby authorized and directed to perform, if said Board of Supervisors consents, include: the preparation, printing and mailing of voter information guides and sample ballots; making such publications as are required by law in connection therewith; the establishment of voting centers and ballot drop boxes, the preparation, printing, mailing and furnishing of vote-by-mail ballots and other necessary supplies or materials to conduct the election; the canvassing of the returns of the election and the furnishing of the results of such canvassing to the Town Clerk of the Town of Fairfax; and the performance of such other election services as may be requested by the Town Clerk.

Section 2. The Town shall reimburse the County for services performed when the work is completed and upon presentation to the Town of a properly approved bill.

Section 3. The Town Clerk shall certify to the adoption of this Resolution and is directed to forward without delay to said Board of Supervisors and to the County Registrar of Voters/Election Department each a certified copy of this Resolution.
