TOWN COUNCIL NOTICE OF PUBLIC HEARING

Notice is hereby given that on **Wednesday, September 7, 2022**, at **6:30 pm** or as soon thereafter as the matter may be heard, the Fairfax Town Council will hold a public hearing on the matters described below at the Fairfax Women's Club, 46 Park Road, Fairfax, and via Zoom teleconference.

- 1. 75 Pine Drive; Variance Application # 22022-18
 Review of a Driveway Width Variance for a project approved by the Fairfax Planning Commission on July 28, 2022, to construct a 1,417 square-feet, single-family residence with a three car parking deck. The parking deck will be 27 feet in width to accommodate the three parking spaces required by the Code, while Town Code § 12.12.030 limits driveways/parking decks for residential properties to 20 feet in width within the public right-of-way. The site is also designated Assessor's Parcel No. 003-101-06, and located in the Residential Single-family RS-6 Zone; Lauri Puchall and Turk Kauffman, architects/owners. The project is categorically exempt from CEQA, § 15303(a) and (e).
- 2. Adoption of a Resolution Adopting Fees for the Short-term Rental Program for Inclusion in the Master Fee Schedule.
