## A MEASURE MAY BE SUBMITTED TO THE TOWN CLERK

**NOTICE IS HEREBY GIVEN** that a Special Municipal Election will be held in the Town of Fairfax on Tuesday, November 6, 2018, and that the polls will be open between the hours of 7:00 a.m. and 8:00 p.m.; and that at said election the following measure will be submitted to the voters:

"Shall the measure continuing the special tax for paramedic se four years in the amount of \$79.50 in the first year and increasi annually to a maximum of \$91.50 per taxable living unit, or per	\$4 YES
feet of structure on a developed parcel in nonresidential use, wannually raise approximately \$296,000 beginning in year one, a the appropriations limit by the amount of said tax be adopted?	

**NOTICE IS FURTHER GIVEN** that direct arguments for or against said measure shall not exceed 300 words in length and shall be submitted (with Argument Signature Form) to the Town Clerk's office, 142 Bolinas Road, Fairfax, California, not later than 5:00 p.m. on Monday, August 20, 2018. The Town Council or any member(s) authorized by it, or any bona fide association of citizens, or any individual voter, or any combination of such associations and voters may submit arguments.

**NOTICE IS FURTHER GIVEN** that direct arguments for or against said measure may be changed or withdrawn prior to and including Monday, August 20, 2018, until 5:00 p.m. and that, when the Town Clerk has selected the direct arguments for and against said measure which will be printed and distributed to the voters, the Town Clerk shall send copies of the argument in favor to the authors of the argument against and copies of the argument against to the authors of the argument in favor.

**NOTICE IS FURTHER GIVEN** that the Town Council has determined that the authors may prepare and submit rebuttal arguments not exceeding 250 words. Rebuttal arguments must be filed with the Town Clerk no later than 5:00 p.m. on Monday, August 27, 2018.
