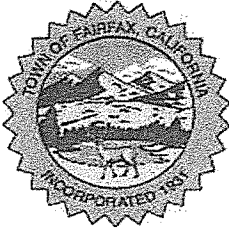


Briefly describe your employment background. I am an attorney specializing in land use law, real property, and environmental justice.
