Vice Mayor Coler presented Ms. Roberts with a Certificate of Appreciation.

### Open Time

Ms. Yvonne Roberts, representing the Manor Hill Fire Wise Group, asked the Council to support adding another Fire Fighter to the department.

Ms. Mallory Geitheim, Willow Avenue, stated people do not know that "compostable" utensils cannot be composted here. She asked about the status of a ban on plastic straws. She asked if the Town could install a dog park under the Contratti Field scoreboard.

Dr. Jody Timms, Fairfax representative to the Commission on Aging, gave a status report. The next Commission meeting will be December 6<sup>th</sup>. She also reported on the activities of the Fairfax Age-Friendly Task Force, Age Friendly Forum, Age-Friendly Fridays at the Library

Mr. Mark Bell, Dominga Avenue, stated the music from the Farmers Market and the Town Picnic violated the Noise Ordinance.

Wendy, Fairfax, stated her there were contractor signs covering some fire hydrants, and she announced a forum on immigrants' rights.

# Presentations

9. <u>MMWD Community-Partner Update: Infrastructure, Water Quality & Environment- Marin Municipal Water District</u>

Mr. Mike Pond, Engineering Manager for MMWD, presented a report on MMWD's current and upcoming projects. He answered questions from the Council.

# **Public Hearings**

10. Introduce and read by title only an ordinance amending Title 17 of the Town Code to add provisions for certain existing medical marijuana dispensaries to conduct delivery of adultuse (recreational) cannabis; exempt from CEQA pursuant to Sections 15061(b)(3), 15301, 15305, and 15183- Town Manager

Town Manager Toy presented a staff report. He answered questions from the Council.

Town Attorney Coleson referred to Section 17.110.230 (A), and recommended the deleting "...a non-storefront retail..." on line 68, and adding. She recommended adding "only" after "delivery" on line 70.

Mayor Lacques opened the Public Hearing.

Ms. Carrie Pratt, President of West Marin Little League, opposed the ordinance. She expressed concerns on behalf of the WMLL about the location of the dispensary so near the baseball field, and that allowing non-medical delivery sales would lead to a storefront and microbusiness at that location.

Ms. Deb Nelson, Spruce Road, opposed the ordinance. She acknowledged the benefits of medical marijuana, but opposed the expansion of the business in its present location.

Mr. Scott Johnston, representing West Marin Little League, stated the location of Marin Alliance was a potential safety issue for the kids who played baseball at Contratti Field.

Mr. Daniel Forrest, Drake High School student, opposed the ordinance, supported West Marin Little League, and stated the dispensary should be relocated away from Contratti Field.

Mr. Larry Bragman, on behalf of Marin Alliance, stated they had been operating at the current location since 1997. He noted allowing delivery would reduce the amount of foot traffic to the dispensary. He supported the ordinance.

Ms. Lynette Shaw, owner of Marin Alliance, supported the ordinance. She introduced the security guard who was onsite during business hours. She stated they were in compliance with the 67 conditions of their Conditional Use Permit and the are 40 pages of rules for the State license.

Mr. Lew Tremaine, representing Marin Alliance, supported the ordinance, noting that the delivery sales would happen off-site, creating a safer situation around School Street Plaza.

Mr. Rick Bagley, Superintendent of the Ross Valley School District, agreed with the concerns expressed by the representatives of West Marin Little League.

Mr. Sean Klein, Snowden Lane, stated he was a substance abuse and mental health counselor, and father of two boys. He supported slowing down the process and protecting children for as long as possible.

Mr. Joe McGarry, Rockridge Road, stated he coached Little League. He opposed a delivery service across the street from where kids play baseball.

Mayor Lacques closed the Public Hearing.

11. Introduce and read by title only an ordinance adding Chapter 5.56 entitled "Cannabis Businesses" to the Fairfax municipal code, Title 5 (""Business Taxes, Licenses and Regulations"), Division II ("Specific Business Regulations") to establish regulations for certain medical marijuana dispensaries to conduct adult-use cannabis deliveries, and consider/discuss proposed application process and permit regulations for adult-use cannabis deliveries; exempt from CEQA pursuant to CEQA guidelines sections 15061(b)(3), 15183, and 15301- Town Manager

Town Manager Toy presented the staff report. He answered questions from the Council.

Mayor Lacques opened the meeting to public comments.

Mr. Don Carney, Mountain View Road and Director of the Marin County Youth Court, asked about additional enforcement efforts specifically aimed at protecting youth.

Ms. Shaw, owner of Marin Alliance, stated there were three "medical-only" products, and discussed the customer order process. She introduced her delivery staff member.

Mr. Dustin Stratton, Marin Alliance, stated he would run the delivery side of the business for Marin Alliance.

Ms. Kelsey Fernandez, local parent, stated the ordinance should address public health impacts and include more to protect the youth, such as requiring an Operation Plan, employee training, a Public Benefits Plan with public health education information, and green business information. She requested a THC limit for products.

Mayor Lacques closed the public comment period.

Councilmember Coler referred to Attachment "B", and made suggestions as follows. Page 3, #7: "The applicant's certificate of commercial general liability....(including, but not limited to, Worker's Compensation, commercial automobile"). Page 3, #10 "A" (ii): "Any arrest or prosecution...manager or employees or other interested parties...." Page 4, "B", add: "The application fee is not refundable". Page 4, VIII (C): "The permittee shall notify the Town Manager in writing...." Page 5, "H" (6) six square feet was too big for the signage. On page 5,

"X" (A): "The permittee may apply...to the Town Manager at least 60 days before the expiration of the permit". On page 6, (C), change 21 days to 30 days, and delete "...the failure of the Town Manager to timely act shall constitute approval of the renewal of the permit." She suggested adding a provision for an employee training requirement, as well, with a process to ensure continued compliance

Planning Director Berto presented the staff report. He answered questions from the Council.

Mayor Lacques opened the meeting to public comments.

Mr. Richard Applebaum, Woodland Avenue, confirmed the ordinance did not create new PDD areas and asked whether the current PDD Zones were already fully developed.

Mr. Frank Egger, Meadow Way, discussed how properties had been zoned PDD, and stated that the current PDD Zones were fully developed. He noted that in the past the Town had imposed specific conditions on developments.

Mayor Lacques closed the meeting to public comments.

Mr. Frank Egger, Meadow Way, was opposed to the ordinance, concerned that it would cut out the part of the process for tree approvals.

Wendy agreed with the comments made by Mr. Egger, and was concerned about people removing trees without approval.

Ms. Patty Patterson had questions about the purpose of the ordinance, and whether it made it easier to deny the removal of a tree.

Mayor Lacques closed the meeting to public comments.
