SUBJECT: Adopt resolution restating and reconfirming the Town is **NOT** exploring or considering the closure of Bolinas Road.

RECOMMENDATION

Adopt resolution restating and reconfirming the Town is **NOT** exploring or considering the closure of Bolinas Road.

DISCUSSION

At its September 2017 meeting, the Council discussed design concepts for the Parkade (parking lot in downtown). During the meeting, public comments were received stating that the Parkade design concepts and potential long range traffic concepts were the "first steps" for supporting the concept of closing Bolinas Rd at Broadway.

The Council reiterated at the meeting that the Town was:

- **NOT** exploring or considering the closure of Bolinas Road and
- **NOT** continuing with the development of the Town Center Plan.

The Council previously made these statements at its October 5 and December 12, 2016 Council meetings to discuss the summary report from the Oct. 1st Town Center Plan workshop. The written staff reports accompanying the items also included the Council's decision to not explore/consider closing Bolinas Road and to not continue with the Town Center Plan.

Councilmember Goddard requested that the Council memorialize its position in the form of a resolution.

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX
RESTATING AND RECONFIRMING THAT THE TOWN IS
NOT EXPLORING OR CONSIDERING THE CLOSURE OF BOLINAS ROAD
OR CONTINUING DEVELOPMENT OF THE TOWN CENTER PLAN

WHEREAS, the Fairfax Town Council stated at its October 5 and December 12, 2016 Council meetings that it is not exploring or considering the closure of Bolinas Road or continuing with the development of the Town Center Plan; and

WHEREAS, the written staff reports accompanying the October 5 and December 12, 2016 agenda items included the Council's decision not to explore or consider closing Bolinas Road and not to continue with the Town Center Plan; and

WHEREAS, members of the public have offered comments at subsequent public meetings suggesting that the Town is considering the closure of Bolinas Road and the development of the Town Center Plan; and

WHEREAS, the Town Council wishes to clarify and memorialize its decision not to explore or consider closing Bolinas Road and not to continue with the Town Center Plan;

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Town Council of the Town of Fairfax that:

1. The Town is not exploring or considering the closure of Bolinas Road in the Town of Fairfax; and
2. The Town is not continuing with the development of the Town Center Plan.
