Conduct interview with youth applicant Lili Ana Secord and appoint her to the youth position on the Fairfax Open Space Committee.

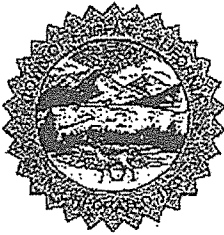
DISCUSSION
