#### Announcements

Mayor Goddard made the announcements as they appeared on the agenda. Councilmember Coler announced that the Pedestrian Flag Pilot Program was launched on Saturday February 27<sup>th</sup>. Councilmember Lacques announced that the fundraiser for Sustainable Fairfax was scheduled for Saturday, April 2<sup>nd</sup> at the Bicycle Museum.

Emma Lauter, creator of the Pedestrian Flag Program, stated she and her friends were monitoring the Pedestrian Flag Program and they noted that about 63 people used the flags at the Elsie Lane and Bolinas intersection and 46 people used the flags at the theater/Parkade crosswalk. They received a lot of positive comments from people.

Councilmember Reed reported he attended the Ross Valley Fire Board meeting; a meeting regarding the Yellow School bus system; the MCCMC meeting; a Transportation Authority of Marin (TAM) meeting; met with various individuals regarding trails; the Bicycle Pedestrian Plan public input session held by Alta Planning.

Councilmember Lacques reported he attended the Flood Zone 9 workshop.

Mayor Goddard reported she attended the Flood Zone 9 workshop; a Ross Valley Healthy Community Collaborative meeting; the Bicycle Pedestrian Plan workshop; the Local Task Force Advisory Committee meeting on Solid and Hazardous Waste.

### Town Manager's Report

Town Manager Toy discussed the recent renovations to the Women's Club, including the rest room, sound system, stage, new memory foam chairs, new dais tables, a new podium and a/v table, and roof repairs. Future renovation plans include new tables, painting the interior, refinishing the floor, installing an ADA lift to make the stage accessible, and upgrading the

lighting. The Pavilion roof was repaired and the solar panels were replaced.

Mr. Joe Garbarino, MSS Co-founder, discussed markets and diversion rates, and supported extended producer responsibility.

Ms. Kim Scheibly, Municipal Contracts & Communications Manager, discussed how they are improving communications with customers, Customer Appreciation Day, and plans for Earth Day.

Mr. Ray Piombo, MSS General Manager, discussed the collection of organics.

There was no public comment. Mayor Goddard closed the Public Hearing.

Town Manager Toy presented a staff report.

Mr. Ryan Skelsky, Executive Director of Marin Patient Access, thanked the Council for being pro-active with respect to regulation. He offered his services to the Council.

M/S, Coler/Reed, Motion to accept the schedules for the delivery standards and for cultivation standards with the following revision to the cultivation standards schedule: the Council will consider the online forum results and discuss Ordinance No. 797 at their April 6<sup>th</sup> meeting, and potentially consider an ordinance at their May 4<sup>th</sup> meeting. Mayor Goddard stated she would like to rearrange the agenda and hear item #14 prior to item #13.

 Introduction and first reading by title only of an Ordinance of the Town of Fairfax Amending Town Code Chapter 17.132, Water Conservation, Reducing the Effective Flush Volumes for Newly Installed Toilets and for Toilets on Properties Involved in Sales or Transfers from 1.6 to 1.28 Gallons. CEQA Categorically Exempt, 14 C.C.R. Section 15061 (b)(3) and 14 C.C.R. Section 15308- Planning Director

Town Manager Toy presented a staff report.

Mr. Larry Bragman, Hickory Road, Marin Municipal Water District Board member, stated the change being considered will bring the Town Code up to California Plumbing Code. He supported adoption of the ordinance, and stated the change had a big impact on water usage.

Mr. Frank Egger, Meadow Way, Ross Valley Sanitary District Board member, stated Fairfax had a history of being progressive on environmental issues. He noted that reducing water use also reduced wastewater. He supported adoption of the ordinance.

Ms. Mallory Geitheim stated the cost to replace a toilet would not be a deal-breaker in Marin County, considering the home prices. She supported adoption of the ordinance.

M/S, Coler/Reed, Motion to Introduce and waive first reading and read by title only Ordinance No. 796, an Ordinance of the Town Council of the Town of Fairfax Amending Town Code Chapter 17.132, Water Conservation, Reducing the Effective Flush Volumes for Newly Installed Toilets and for Toilets on Properties Involved in Sales or Transfers from 1.6 to 1.28 gallons. AYES: Coler, Lacques, Reed, Weinsoff, Mayor Goddard
