select a candidate or defer the decision to the next Council meeting

## RECOMMENDATION

Conduct 1<sup>st</sup> and 2<sup>nd</sup> round interviews and either: 1) continue the appointment process to the next Council meeting, or 2) select an applicant to fill the vacant seat

## **DISCUSSION**

At its December 3<sup>rd</sup> meeting, the Council decided to pursue the Council-adopted process (attached) to appoint a person to fill the remaining term of the seat vacated by Councilmember Bragman. Staff began the process by accepting applications for the vacancy. The attached six applications were submitted by the January 5<sup>th</sup> deadline.

The six applicants were invited to tonight's meeting to be interviewed. Each applicant has been provided with a copy of the attached interview process. Per the process, each applicant will have ten minutes to make an individual presentation to the Council, inclusive of Council questions.

After all of the applicants' presentations and Q&A, each Councilmember will select his/her top two applicants. Staff will create a list of the finalists based on the Council's vote. The Council will need to decide how many of the finalists should participate in the second round of interviews. According to the adopted process, depending on the number of finalists, the Council would allocate 5-10 minutes for additional questions of the candidates. At the end of the second round, the Council may rank the candidates and make their selection or defer their decision to the next Council meeting. In 2013, the Council deferred its decision until the next Council meeting for an additional round of interviews of the selected finalists.

In terms of timing, the 60-day period for the current vacancy on the council ends February 3, 2015, prior to the next regular meeting. Therefore, the Council has previously set a special meeting on January 28<sup>th</sup> for the purpose of selecting and making their appointment. However, January 28<sup>th</sup> is also the Marin County Council of Mayors and Councilmembers (MCCMC) monthly meeting. In order to attend the MCCMC meeting scheduled to begin at 7:00 pm, the Council would need to hold its special meeting significantly earlier than 7:00 pm to allow time for the interviews and selection. The other option is to select another day for the special meeting.

I've spent a lifetime engaged in community work including recycling, political organizing, work in several food cooperatives, helping refugees, educating myself on energy issues, and working for 20 years for the Midwives Alliance. Many of these were unpaid work, but I've always tried to make the work I do for pay be consistent with my values, such as engaging in research on photovoltaics and development of several laboratory and medical instruments.

## WHY DO YOU WANT TO BE CONSIDERED FOR THE POSITION OF TOWN COUNCIL MEMBER?

This is an opportunity to contribute to the Town and beyond. I was privileged to work on GPAC, guiding our wonderful community process to craft a General Plan. Through that process I learned a good deal about Fairfax, so I hope to be at a point now where I could contribute to the Council.

I was encouraged once before to run for Council, but when Larry Bragman came forward I was happy to bow out. It now seems to be the right time to take my turn on the Council.

I believe that I could bring an understanding of Fairfax's needs, while respecting multiple viewpoints and encouraging creative discussions based on complex and nuanced information. Informed by my scientific and technical background, I try to approach decisions with an open mind, but with a determination to engage the major challenges of our age.

## WHAT ARE THE THREE MAIN ISSUES FACING THE TOWN OF FAIRFAX?

Climate Change and Sustainability: Without a doubt the overriding issue of our time is climate change, along with the many other ways in which our life is degrading the planet and cannot be sustained. Government at all levels is only slowly addressing these issues, though some noteworthy successes have arisen from Fairfax, Marin and California. While Marin citizens and policy makers have a deep commitment to protecting the natural environment and to justice for all people, we nevertheless have an outsized footprint and are far from living within our means. Locally we should focus on the efficiency of our buildings, minimal use of materials, and widespread use of ecological options to reduce and rethink transportation. Through Marin Clean Energy and other means we have an outstanding opportunity to become net energy producers, enjoying revenue as well as resilience as we do so.

Public Education: As we address the need to restore the planet and adapt to rapid and irreversible changes both physical and economic, we need to educate ourselves so our actions are effective and creative. We need to tame our tendency to lead with our opinions, letting a deeper understanding of the facts guide our decision making. The brilliance of our people can best be brought to bear if we create an environment in which knowledge and experience are valued, and contribution to the public discourse is rewarded.

Democracy: The deciding factor determining how successfully we rise to our great potential in these times of challenge and opportunity will be whether we can maintain civil discourse. Fairfax has deep values of democracy and civic engagement, but many of our 7500 citizens find the public process to be too contentious to participate in. With patience, active listening, and respectful discourse, Fairfax can continue to be a leader as we globally navigate a positive, joyful conversion from a consumer-based society to one built around love of nature, community, arts and play, living lightly on the land we love.

We have a fabulous Town Council and Planning Commission, the best I've seen in my years here, and many great committees and volunteers – we are well placed for this transformation.

## WHAT IS YOUR VISION FOR THE TOWN OF FAIRFAX?

I envision our town as a strong, smart community in which all our citizens *enjoy* being involved, in which true democracy shines, and which becomes less and less dependent on external sources of goods, services and energy, and more and more truly at place among the green hills surrounding us.

I envision citizens being able to work at home and in the town, with less need for frequent commutes and using effective transportation options when we do travel.

I envision diversity thriving and making our town ever stronger, more resilient and more fun, as we find ways to remove the barriers so those who work in our shops and restaurants, care for elders or do construction are able to live here and be part of the community at all levels.

I envision our economy becoming more localized, particularly as we enjoy the produce of local farmers and ranchers and as we produce more of our energy locally. We will become more resilient to the global shifts underway, and focus our lives on the rewards of bringing every bit of the intelligence and world-class experience of the Bay Area's people to reimagine our life on this earth.

I envision all the changes we make locally having wide-ranging benefit as Fairfax continues to be a beacon for others, of hope and best practices for community, democracy and sustainability.

## WHY DO YOU WANT TO BE CONSIDERED FOR THE POSITION OF TOWN COUNCIL MEMBER?

I care deeply about our community and the challenges we are facing. Ultimately serving on the Council is about making decisions for the whole community, by considering the needs of the community and the divergent views of the community. I think that wherever and whenever possible, it best to try to build consensus for decisions. Where consensus is not possible, it is crucial make sure all points of view are heard and considered. While much of my work as an attorney is to be an advocate, much of my work also involves collaboration with clients and opposing parties to reach amicable settlements. Ultimately, Democracy is a collaborative and sometimes messy process, but I enjoy the collaborative process, too.

I place a high value on mutual respect, and the right for everyone to be heard and the importance of refraining from personal attacks. I am very encouraged by the increasing civility that our Council has cultivated over the last several years and pledge to uphold that culture.

I don't bring any agenda with me. But what I think I do bring is an ability to hold differing points of view when weighing a decision and an ability to make decisions based on the merits of the decision, and not personal feelings or for political purposes. I think I also bring an ability to bring people together and to avoid needlessly polarizing issues.

I think my skills as an attorney are also very valuable for serving on the Council. I have a keen understanding of Constitutional Law and statutory interpretation, as well as word-smithing skills that would be very valuable in weighing legal issues and drafting ordinances, and reviewing contracts, MOU's or inter-agency agreements. I have extensive practice experience in the areas of employment law, civil rights, tort law, contracts, real estate, and land use and a working knowledge of CEQA, CERCLA and other environmental statutes.

## WHAT ARE THE THREE MAIN ISSUES FACING THE TOWN OF FAIRFAX?

## 1. Maintaining core town services in light of difficult fiscal environments.

This is a never ending challenge. Fortunately recent tax measures were passed to keep the town funded. This is also encouraging because it shows our citizens value and appreciate local services and are willing to pay a little extra to maintain our town's services. To further safeguard our fiscal resources, it is critical to scrutinize all public contracts and ensure careful bidding processes are followed. It is also important to look for cost-saving measure and efficiencies which don't

compromise quality of services.

2. To maintain our unique environmental quality of life – both in the natural sphere and the human-constructed sphere. We are blessed to live one of the most livable small towns in America, set in one of the most beautiful natural environments in America. Fairfax is consistently voted best town to live in the Pacific Sun. Eight years on the planning commission has taught me that quality of life is the aggregate affect of hundreds of small decisions over time.

One of the biggest quality of life issues affecting Fairfax is transportation and traffic. It is crucial to advocate for better public transportation to serve us and surrounding community, while providing the infrastructure to support public transit and making planning decisions that are sensitive to traffic impacts. We also should continue to create a more pedestrian and bicycle friendly town. I would like to seek out funding from TAM/MTC to continue to upgrade bike lanes and more amenities for bikes such as bike racks and improved sidewalks and pedestrian infrastructure.

3. Revitalize Downtown - Town Center element suggests a number of intriguing improvements. The extension of Elsie/Bank street to S.F.D. Blvd, merits a close look, including a careful traffic impact study to ensure other neighborhoods or corridors are not negatively impacted. Taking car traffic off Broadway and Bolinas may result in a more vibrant downtown, and better traffic flow in and out of town. At the same time this can create a more-pedestrian oriented destination which in turn can improve local businesses. Let me stress however, this requires careful thorough planning and traffic studies to more fully assess the benefits and downsides before proceeding. At the same time we need to address long overdue improvements to the Parkade and especially public transit infrastructure could also enhance downtown. I think as downtown becomes more vibrant, parking is going to become a much bigger issue.

## WHAT IS YOUR VISION FOR THE TOWN OF FAIRFAX?

There is a vital need to create more real affordable housing; there is a tension with meeting the bureaucratic goals of HDC and /or ABAG and the up-zoning changes they tend to promote vs. actually building affordable housing that low-income or even moderate-income people can actually afford. Ultimately, I think what will get it done in Fairfax (which has far fewer opportunity locations than larger towns and cities) will be non-profit and/or publicly subsidized projects. Additionally, second unit amnesty and permits are especially important for Fairfax to meet our community needs. I think there has been some counterproductive polarizing of Application of Peter Lacques for Fairfax Town Council

affordable housing issues that has obscured the subtler nuances of this complex challenge.

I would like to see an emphasis on Disaster preparedness and developing a robust local response to the catastrophes that we can almost count on. We have been lucky in that there has not been a major fire in this area since the 1920's. Unfortunately, the fuel load gets worse each year and the box canyons that comprise Fairfax could become conflagrations under the right conditions. We need to develop a neighborhood by neighborhood evacuation routes and instructions and share these with our residents. Climate change, now underway, will make the conditions for floods or fire more severe. And in the event of a large scale earthquake, we might find ourselves cut-off from outside agencies (or they may be too overwhelmed to assist).

The Town has taken some great steps toward increasing participatory democracy such as televising meetings on the web and improving the general tone of the council meetings. I'd like to see that trend continue, and more of our citizens engaged.

I would like to see the Pavilion utilized more as a community resource and improved and upgraded.

I would like to see more open space acquisitions; a large part of our quality of life in Fairfax our abundant open space.

As other outlets to express democratic ideals are becoming more constrained, being outspoken on public issues which reflect the community's values is vital, whether it's speaking out against the Patriot Act, fracking, or encouraging Divestiture from Fossil Fuels. And ultimately, these larger issues affect us here, directly and indirectly.

In sum, my vision for Fairfax is to maintain our strong community values, environmental ethos, quality of life and small town charm while intelligently adapting to challenges in the future.

WHY DO YOU WANT TO BE CONSIDERED FOR THE POSITION OF TOWN COUNCIL MEMBER? I have been a proud member of the Fairfax community for over two decades and I now feel qualified to play a stronger role in our local government. I feel I can bring a reasoned approach to the issues we face as a town—I'd like to deepen the dialogue between the community and the Council and add my voice on our present and future direction. I believe I have a great deal to offer the Town given my broad base of experience working with non-profits, small businesses and local County government (11 years with the County of Marin Community Development Agency and the Department of Health & Human Services). In the last year and a half I have gained

more local experience working with our town staff and the Council on matters of importance to all of us who live in Fairfax-development, housing, seniors and climate change. My personal and professional background, education and training in the fields of health care, senior communities and emergency services would be especially valuable. I have also been both politically minded and a community organizer since my early twenties. In particular, I have been part of the women's and environmental movements for many years, most recently working closely with 350.org (and its local groups) and with Citizens Climate Lobby, having taken a trip last summer to lobby congressional representatives in Washington D.C.

WHAT ARE THE THREE MAIN ISSUES FACING THE TOWN OF FAIRFAX? In my opinion, the first of these would be making significant progress on implementing our 2010-2030 General Plan, with its eight dynamic elements. Twelve years in the making, it is our "community's priorities and dreams for a sustainable future." Second, we need to address in the present and prepare for the future rising number of seniors in our community. In the next 15 years, countywide the number of those over 60 years old will increase from 27% to 33%. Clearly identifying the needs of our Fairfax seniors and collaborating on short, medium and long-term goals is critical. And third, we need to be better prepared for emergencies and natural disasters, especially in light of the climate change scenarios of fires, drought, floods, sea level rise, etc. Building a network of CERT trained residents who can coordinate effectively with first responders will ensure the least damage to people and property. Each of these issues requires very thoughtful planning, community engagement and measured implementation over time but with urgency as well. I look forward to addressing each of these issues in more depth at the January 14<sup>th</sup> Town Council Meeting.

WHAT IS YOUR VISION FOR THE TOWN OF FAIRFAX? Fairfax is a vibrant and soulful community—I'd love to see more people actively involved with each other and with the community at large. I see Fairfax as a strong intergenerational learning community with citizens passionately engaged in thinking through our issues and problem solving together to enhance and protect our town and participate in healthy local and regional social and political change.

The Council plans to interview applicants at its next regularly scheduled meeting on Wednesday, January 14, 2015. The Council anticipates appointing a candidate at a special meeting to be held on Wednesday, January 28, 2015. Prior to the interview each applicant will receive a letter confirming the time and date.

Attached for your reference is the Council-adopted interview process. Please note the questions the Council would like each candidate to address in his or her initial presentation.

## Council-Adopted Process for Interviews and Selection

- 1. When the applicants arrive, staff will randomly draw numbers to set the order of the presentations.
- 2. As a courtesy to the other applicants, Council will request that all applicants wait in the lobby or other waiting area while any one applicant is making his/her presentation.
- 3. Each applicant will have 10 minutes to make a presentation and to answer any questions from the Council. Applicants have been given the following three questions to cover in whatever level of detail they desire in their presentations:
  - Cite three top goals for the Council and your reasons for considering them high priority.
  - What program/budget areas would you advocate be increased, and how would you fund these increases?
  - Please give us more detail on what your vision is for the Town of Fairfax.

The questions are meant to provide some basis by which the Council can compare the presentations. Staff will set the timer for 10 minutes and presenters will be informed when 1 minute remains. No additional time will be permitted.

- 4. After the presentations are completed, all applicants will be invited back into the meeting room to hear the first step in the Council deliberations.
- 5. The first step will be for the Council to create a list of finalists by having each of the Council select his/her top two applicants. Staff will create a list of the finalists based on the Council vote.
- 6. One by one (in alphabetical order by last name), the finalists will then be interviewed by the Council.
- 7. Once again, the Council will ask that all of the finalists leave the meeting room and return to the lobby while any one finalist is being interviewed. The Council will ask questions of each of the finalists. Finalists will have 5 minutes to answer questions, if more than three (3) finalists are selected. If 3 or fewer finalists are selected, then each finalist will have 10 minutes to answer questions.
- 8. When all interviews have been completed, all finalists will be invited back into the meeting room to hear the final step in the deliberations.

- 9. Each Councilmember will then rank his/her choices, with Rank 1 earning 3 points Rank 2 earning 2 points, and Rank 3 earning 1 point. Staff will tally the points and report the results to the Council.
- 10. Town Council will, by motion, make their decision that night or defer it to another meeting.
- 11. When the Council makes its decision, the newly appointed Councilmember will take his/her oath of office immediately and be seated at the meeting.
