Mayor Coler called the meeting to order at 7:00 pm

Approval of Agenda and Affidavit of Posting

M/S, Weinsoff/Reed, Motion to approve the agenda and the affidavit of posting. AYES: Goddard, Lacques, Reed, Weinsoff, Mayor Coler

Announcement of Closed Session Action

Mayor Coler announced there was nothing to report.

Announcements

Mayor Coler made the announcements as they appeared on the agenda, adding the Great Shake Out event. Councilmember Goddard announced that a Sustainable Fairfax bicycle tour of household rainwater catchment and gray water systems.

Open Time

Mr. Sierra Salin discussed a variety of subjects including support rent control, the absence of people aged 18 to 25, the importance of programs of choice in our local public schools.

Ms. Li-Chien Bell, Dominga Avenue, was concerned about the condition of the bridge that runs between Dominga Avenue and Forrest Avenue, and requested the Town remove ivy. She expressed concern over the noise coming form downtown. She supported reducing the speed on Dominga Avenue to 15 mph.

Ms. Jody Timms, Fairfax Representative to the Marin Commission on Aging, reported on its activities.

Ms. Emma Lauter, representing the Reduce by Two Committee of Sustainable Fairfax, discussed pedestrian safety in crosswalks and proposed a trial use of pedestrian flags at certain intersections in Town, offering to provide the flags.

Ms. Linn Walsh, and Mr. Eric Leland, and Mr. Graham Irwin, Dominga Avenue, discussed a traffic-calming effort they engaged in ("Slominga") for Dominga Avenue and Napa Avenue. They supported the use of pedestrian flags.

Ms. Anya Chandler, Barker Avenue, was in favor of the use of pedestrian flags. She suggested the use of signage on Chipper Day to further publicize the event.

Mr. Joseph Odem, Porteous Avenue, supported the use of signs for Chipper Day, and expressed concern regarding the vegetative debris that appeared to have been thrown over the fence where properties on his street backed up on open space. He asked for help in working with neighbors to encourage them not to throw debris onto the open space, as it created a fire hazard.

Paul Neal, Westbrae, discussed the recent homicide, noted quality of life issues, and thanked the police for the help.

Presentations

Marin Business Emergency Readiness- M'Ber project- Garry Lion, Vice Mayor, Mill Valley

Mill Valley Vice Mayor Garry Lion discussed the M'Ber project and gave a Powerpoint presentation.

Ross Valley Flood Protection & Watershed update, including detention basin sites- Scott Lyle, Program Manager

Supervisor Katie Rice introduced Mr. Scott Lyle, Program Manager.

Mr. Scott Lyle presented a Powerpoint presentation on the proposed detention basin systems and answered questions.

Mr. Frank Egger, Meadow Way, had questions about the reduction in the flood level once the detention basins were built. He was concerned about undersized culverts and king tides.

Mr. Michael Macintosh, noted politics influenced the decision-making process, which was also driven by consultants who are paid for by taxpayers.

The Council thanked Supervisor Rice and Mr. Lyle for the presentation.

The Council took a 10-minute break at 9:20 p.m.

Mayor Coler rearranged the order of the agenda: Councilmember reports and the Town Manager report would be heard after the regular agenda. Item #7 would be heard after item #11.

Regular Agenda

<u>Discussion/consideration of retrofitting streetlights with LED fixtures and participating in PG&E programs to manage and finance the retrofit project- Town Manager</u>

Town Manager Toy gave a staff report.

The Mayor noted that Marin Clean Energy did not handle such projects for government.

Councilmember Reed had concerns regarding the color temperature of the LEDs, and confirmed the Council would have control over it even with the turnkey program.

Councilmember Lacques expressed concerns over the amount of light, flickering.

Mr. Bruce Ackerman discussed the roles that Marin Clean Energy and PG&E could play in this program. He had questions about PG&E's turnkey program.

Ms. Cassidy DeBaker, member of the Climate Action Committee, agreed with the comments made by Mr. Ackerman. She noted the initial discussions focused on the downtown area.

It was the consensus of the Council to direct staff to look at two options (cobra-heads only, and cobra-heads and top hats) and a pilot demonstration, and to consider greenhouse gases.

Authorize the Vice Mayor to send a letter to the Metropolitan Transportation Commission (MTC) requesting them to fully fund the Association of Bay Area Governments (ABAG) for FY 15-16 and to expand their evaluation of the potential consolidation of MTC and ABAG planning departments- Vice Mayor Goddard

Town Manager Toy gave a staff report.

Councilmember Reed requested language be added regarding ABAG's obligation to represent and work with local governments.

M/S, Weinsoff/Reed, Motion to authorize the Vice Mayor to send the letter with an additional sentence or two reflecting Councilmember Reed's request, to the Metropolitan Transportation Commission (MTC) requesting them to fully fund the Association of Bay Area Governments (ABAG) for FY 15-16 and to expand their evaluation of the potential consolidation of MTC and ABAG planning departments.

<u>Discussion of financing Town infrastructure through low-interest capital loans from other governmental entities- Town Manager</u>

Town Manager Toy gave a staff report.

It was the consensus of the Council to direct staff to continue to pursue this matter and to get an analysis of the comparison bond debt.

Councilmember Lacques noted that he had not supported bifurcating this ordinance at the first reading, but that he supported this part of the bifurcation.
