**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX
DESIGNATING TOWN MANAGER GARRETT TOY
AS THE AGENT FOR THE TOWN OF FAIRFAX FOR THE CALIFORNIA
EMERGENCY MANAGEMENT AGENCY (CalEMA)**

WHEREAS, the Town has sustained damage to Town property during significant storms in 2005-2006; and

WHEREAS, the Town has sought funding for the repair of the storm damage to the Town's property during that time;

NOW, THEREFORE, BE IT HEREBY RESOLVED, for and behalf of the Town of Fairfax, a public entity established under the laws of the State of California, that applications have been filed with the California Emergency Management Agency for the purpose of obtaining certain federal financial assistance under Public Law 93-288 as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, and/or state financial assistance under the California Disaster Assistance Act.

THAT the Town of Fairfax, a public entity established under the laws of the State of California, hereby authorizes its agent to provide to the California Emergency Management Agency for all matters pertaining to such state disaster assistance the assurances and agreements required.

This is a universal resolution and is effective for all open and future disasters up to three (3) years following the date of approval below.
