SUBJECT: Approval of the Notice of Completion for the Sir Francis Drake Bike Lane Striping

Project

RECOMMENDATION

Authorize the Town Manager to issue a Notice of Completion for the Sir Francis Drake Bike Lane Striping Project.

DISCUSSION

The Sir Francis Drake Bike Lane Striping Project (Project) extends from roughly Bank Street to Olema Road along Sir Francis Drake Blvd. On August 7, 2013, the Council awarded the contract to the Chrisp Company for both the base bid and alternate bid amounts in a not-to-exceed amount of \$49,704.60. Staff did approve two change orders: 1) an additional \$1,135.40 to account for minor increases in some quantities from the estimates on the bid schedule versus actual installed and 2) an additional \$2,480 for remarking the left hand turn from Sir Francis Drake to Olema Rd to correct an existing field condition.

The Town is required to file a Notice of Completion (Notice) with the Marin County Recorder's office. The project engineer/construction manager, Coastland, confirms that Chrisp has completed the project and recommends issuance of the Notice of Completion. Upon the recordation of the Notice, staff will release the 5% retention to the contractor.

FISCAL IMPACT

The Council approved a project contingency reserve of \$5,000 to be used by the Town Manager to cover unforeseen project costs. The project experienced additional change orders totaling \$3,615.40. The total final construction cost is \$53,320. The Project is budgeted in Fund 51-CIP-Grants (Project #51-891-821).

The Project was initially funded with \$80,000 in federal Nonmotorized Transportation Pilot Program (NMTPP) funds. We had previously spent approximately \$20,000 for design costs of which \$12,000 was reimbursable under the grant. As a result, there was \$68,000 in NMTPP funds remaining for construction and bid preparation/construction management (CM) costs.

The combined costs of construction and CM services are \$77,320 of which \$68,000 will be reimbursed by the NMTPP grant. The difference of \$9,320 will be covered by the Capital Project fund (Fund 51).
