SUBJECT:

Approve change order to the contract with Maggiora & Ghilotti for the Parkade

Improvement Project to include the repaving of Mono Avenue (Mono Alley) from

Bolinas Road to Pacheco Avenue in a not to exceed amount of \$59,743.

RECOMMENDATION

Authorize the Town Manager to approve a change order for the contract with Maggiora & Ghilotti for the Parkade Improvement Project in an amount not to exceed \$59,743 for the repaying of Mono Avenue (Mono Alley) from Bolinas Road to Pacheco Ave.

DISCUSSION

In December 2019, the Town Council awarded the contract to Maggiora & Ghilotti, Inc. (M&G) for the Parkade Improvement Project. In essence the work is the reconstruction of the parking lot, which includes asphalt concrete overlay (paving). Mono Avenue between Bolinas and Pacheco is located near the Parkade and is used frequently by vehicles including trucks in the downtown area. Mono Alley is in a highly deteriorated state of disrepair with a pavement rating (PCI) of 22, which means the pavement no longer has any remaining useful life. The PG&E pipeline work in Mono Alley demonstrated the need to reconstruct the road. PG&E did contribute funding to repave a portion of Mono Alley.

M&G has indicated we could save significant mobilization costs and time for the project if we combined it with the Parkade Improvement Project, since most of the same equipment and materials would be used for the paving of Mono Alley. The project entails the grinding and repaving of Mono Alley with a 4-inch asphalt overlay. Staff believes this a cost-effective approach for repaving Mono Alley. We estimate a savings of between \$8,000 to \$12,000 in mobilization costs and the cost of preparing plans and specifications for the project, as well as the time to publicly bid the project. It should also be noted that the amount is within the Town Council's authority to award a negotiated contract. An additional efficiency is that the work can be performed under an existing contract. Attached is the cost estimate for the change order.

FISCAL IMPACT

The cost for repaving this portion of Mono Avenue will be charged to the FY18-19 CIP budget in Fund 53-887 "Street Resurfacing & Repair"
