SUBJECT: Authorize the Town Manager to negotiate and execute agreements with Tyler

Technologies, Inc for Tyler InCode accounting software as a cloud-based service

(SaaS), in an amount not to exceed \$100,000.

RECOMMENDATION

Approve contract with Tyler Technologies, Inc. to lease Tyler Incode accounting software as a cloud- based service (SaaS) and authorize the Town Manager to execute the agreement in an amount not to exceed \$100,000.

DISCUSSION

For the past twenty-five years, the Town has been using Banyon Data System (BDS) accounting software and numerous other programs and services for general ledger, permitting, business licenses, payroll, fixed assets and cash receipts. This requires numerous monthly financial journal entries to enter subsidiary activity to BDS and limits the usefulness of the finance system. Budgeting is done manually using extensive Excel and Word files. Financial reports are limited in the BDS software and is limited to three years of comparative data.

The Finance Department has been looking into accounting software alternatives to integrate, update and streamline financial transactions. To that end, the Town has set aside \$100,000 in the Equipment Replacement Fund (Fund 8) for replacement financial software. Based on reviews and onsite demonstrations last October, staff chose Tyler Incode. The decision was made easier by the fact that Tyler is also used by several neighboring municipalities including San Anselmo, Corte Madera, Larkspur, Mill Valley, San Rafael, and recently was chosen by the Central Marin Sanitation Agency.

Staff decided to go with a cloud-based system rather than purchase/license the software to run on Town servers. The purchase cost is higher in the first year due to licensing costs, but the annual maintenance fee is less in subsequent years. (See Attachment A). These costs don't include our own cost of IT support and staff time to maintain the financial software (i.e., install updates). It is unclear whether the Town would need to purchase a new server to run the system.

The cloud-based SaaS Model allows us to have a fully operational system without the headache of having to maintain a server onsite. All we need is a computer with internet access. Also, within the SaaS Model, we will have automatic software updates, backups and disaster recovery built in. The vendor takes care of everything.

Purchasing, maintaining and backing up an on-premise server would likely require additional IT support costs and the system may experience longer delays for software updates, file back-ups, and /or server glitches. Under the SaaS Model maintaining a simple computer can be done by anyone not requiring a technical background.

Finance staff surveyed neighboring cities using cloud-based software and the general consensus was it would be the best choice. The Finance Committee discussed the Tyler financial software at their October meeting and was in favor of the cloud-based version.

Implementation of the Tyler Incode software will take six to eight months or more. Initially, it will involve Tyler personnel being onsite to "shadow" the accounting processes to customize the integration of the accounting modules. We will have a project timeline once we commit to the acquisition.

FISCAL IMPACT

New integrated financial software represents a major improvement to the business processes for the Town of Fairfax. Major efficiencies will be gained through improved productivity, automation, and best practice processes. Having integrated software will improve the transparency of financial activity and make it possible to use software such as OpenGov to permit citizens and staff to inspect and manipulate financial data for special reports.

The price for the cloud-based system is about \$90,800, including:

- \$46,000 for Implementation;
- \$19,250 for Data conversion (This will be higher if we decide to transfer more than two years of data); and
- Project management and travel costs of approximately \$25,550.
- \$9,000 project contingency.

The complete quote is in Attachment C. The annual fee will be about \$45,000, compared to our current costs of \$13,300/yr (Attachment B). All costs are expected to be incurred next fiscal year.
