- 2. Approval of agenda and minutes from 11/23/10 meeting

- 4. Discussion re: Management of Elliott Nature Preserve / Cascade Canyon
 - a. Discussion of December 30, 2010 letter from Martha E. Ture to Fairfax Open Space Committee regarding the Elliott Nature Preserve (letter attached to minutes). Discussion primarily led by letter's author, Martha Ture. The letter and discussion centered on the idea of rotating the location of the annual "Turkey Day" bike ride. Linda Dahl of the Marin County Open Space reported that the Marin County Board of Supervisors convened a meeting last February and instructed the Marin Open Space District to do a comprehensive road and trail management plan. Linda Dahl reported Marin County Open Space is working to convene the known eight organized bike groups, equestrian groups and other interested parties to discuss the issues involving the annual Turkey Day bike ride. Action Item: Linda Novy of FOSC volunteered to attend various meetings on aspects of this issue and report back to FOSC to recommend any further actions. Mimi reminded everyone that the FOSC role is to provide advice on this issue to the Fairfax Town Council.
