1. Roll call: Mimi Newton, Barbara Coler, Helen Fauss, Denise Ferry, Ruth Horn,

2. Approval of agenda (agenda revised to move item 8 after item 4)

3. Approval of minutes of May 27, 2008

4. Presentation and discussion – Sudden Oak Death (SOD) – Ray Moritz, licensed arborist: background provided on appearance in Marin County ~1991, after plantings of rhododendron (a known host of SOD). Ray is a forest scientist who has done research on SOD and served on CA Oak Mortality Committee. Various treatments explored by Marin Co. arborists. Two types of SOD: 1) attack roots & 2) attack aboveground tree. Phosphenate is most effective on trees in the field. Australians developed "agriphos" (same family as phosphenate) which stopped sporilization and tried on SOD, relatively effective. Mineralization of soils- no scientific evidence that it treats SOD, but makes trees healthier. Lime also used on tree trunks – no scientific evidence that this treats SOD. AgriFos (phosphoric acid¹ mixed with "penta-bar), scientific evidence that it treats SOD, if cankers are not extensive. It is not a cure, "holds it" and needs continued treatment into the future (twice in the 1st year, once every 12-18 months). The is great variation in two Marin Co. oaks in their resistance to SOD, e.g. Interior Live Oak has not shown SOD, found on Mt. Tam. Discussion of replacement trees, stated that bay laurel has come in other areas. Suggested looking as far as Santa Barbara County for replacement species of Oaks.²

- A. Access issues Larry Bragman letter received from the owner, read to FOSC. Essentially owner is not interested in entering into an agreement or access to the extent required by the easement. Posting signage suggested for City Council discussion.
- B. Signage and dedication Denise Ferry discussion of text FOSC voted for 5mph for bikes along with existing text; Denise to forward signage text to Larry for City Council discussion. Dedication continue to next month.
- C. Removal of creek obstruction Mimi Newton pending; continue to next month.
- D. Management Plan review Mimi Newton continue to next month.
- 6. 120 Day Report: Subcommittee to review Ridgeline Ordinance and map consideration of purchase of GPS Ted Bright, Ryan O'Neil, Niccolo Calararo, Ruth Horn. Larry Bragman suggested strengthening the ordinance with map. Logistics of scanning and preserving the map discussed. Action item: staff to locate map and follow-up with Larry.
- 7. Update: The Wall Property
 - A. Council letter to Dr. Wall staff no response to date.
- B. Grant application package Helen Fauss pending, need resolution on property price and is the property on the market. Inquiries ongoing. Staff should check Tax Assessor's office on reassessment, etc.
- C. Letters to Hal Brown, Jared Huffman, San Anselmo (urban green zone) Mimi Newton Larry provided draft language to Hal Brown to FOSC; signatory would be Fairfax Mayor or Town Manager.
 - E. ABAG Mimi Newton- continue to next month.
 - F. Additional item Marin Open Space Trust (MOST) Mimi Newton they voted to work with FOSC on acquisition. FOSC should take Bill Long and another MOST member on field trip.
- 8. Discussion and action: Cascade Canyon Preserve County management and EIR proposed change – Terry Goyan (not in attendance). Informational item: Linda Novy and Martha Ture – background on Cascade Canyon and White Hill Land Management Plan and EIR (adopted 2005) with lists of priorities. Strategic Plan (with appendices) adopted June 2008. Cascade Canyon is listed with most dangerous open space areas for fire. Priorities of EIR (Priority 1s in particular) have not been implemented and they are concerned that they may be circumvented. Seeking FOSC support and letter (FOSC and/or City Council) for implementation of Priority 1 items from EIR. Three items noted regarding the letter re: Cascade Canyon: 1) concerned with Fire safety; 2) are they using EIR priorities e.g. not opening Split Rock area for mt. biking (alt. language – concerned with safety of those in the preserve); 3) adopting steel head management plan (alt. language – concerned with resource management). Request that the District stay with the priorities in the EIR. Also note that the District is looking fro Fairfax Police to patrol at night. Action item: Novy and Ture will send EIR Cover page with Executive Summary and priorities to FOSC and critical points where City support is requested (& highlight where there have been violations/changes from the EIR) – 30-45 days. Linda will send Strategic Plan and appendices to FOSC; appendices to Larry. Possible field trip for FOSC after staff review conducted of these materials.
- 9. Treasurer's Report: Ted Bright continue to next meeting. Inclusion of Open Space funds re: City Council budget discussions. Larry will agendize this item.

- 10. Discussion of dates for August joint meeting with San Anselmo Open Space Committee FOSC agreed to joint meeting in August.

- 12. Update: Council approval for acquisition of Ben Ross Property at June 4th meeting Mimi Newton and Ian Roth owner seeking release from \$400K loan, property sale for \$800k. Owner interest in \$00K upfront; wait for later funds. County Open Space may have matching funds. FOSC expressed enthusiasm to continue to pursue.
