DISCUSSION

The attached financial reports (Revenues & Expenditures) summarize the Town of Fairfax fund operating results for the ten month period ending April 30, 2019. April represents **83.3%** (10/12) of the fiscal year. The monthly (interim) financial reports are prepared on a “cash” basis. As a result, certain revenue and expenditure accounts may not reflect the actual month’s activity due to the timing of when revenue is received or expenditure is paid. Some revenues (or expenses) belonging to June are received in (or paid) in July, August and September. Conversely, some receipts and expenditures at the beginning of the fiscal year are for the prior fiscal year.

Revenues:

The biggest sources of General Fund revenues are property taxes received in December and April, and revenues from transfers. General Fund receipts in April were \$1,402,341, mostly due to property tax receipts and year-to-date were \$5,805,754 (58.0% of budget). YTD Sales tax revenues (including add on taxes and before the addition of the County Prop 172 sales tax revenue) are \$1,154,818 (84.0% of budget). YTD Utility Users Tax (UUT) receipts are \$301,451 (88.7% of budget). YTD revenues posted through April 30th for all funds total \$ 10,082,822 (57.5% of budget).

Expenditures:

General Fund expenditures were \$747,305 in April and \$7,981,523 year-to-date (76.2% of budget). Total expenditures posted through April 30th for all funds were \$9,834,502 (55.9% of budget). The largest disbursement in April, other than transfers or payroll, was the payment of \$194,905 to Ross Valley Fire Dept. for May fire services. The check register, CalCard register and the EFT payment register are attached.

Cash held with fiscal agents for debt service/lease payments is not included. The Local Agency Investment Fund (LAIF) interest rate for April 2019 was **2.445%** which is up .009 percentage points from the prior month and .784 percentage points from April 2018. (Note: The LAIF interest rate risen each month since December 2014 when it was at .262%)
