306 Scenic Road; Application # 19-08

Request for a use permit and variance to construct a 6 to 8 foot tall retaining wall along approximately 28.5 feet of the western property line adjacent to an accessory dwelling unit under construction on a site developed a single-family residence; Assessor's Parcel No. 001-051-19; Residential Single-family RS-6 Zone District; Selander Architects, architect; Krystin Rubin and Karen Heisler, owners; CEQA categorically exempt, § 15301(e)(1). Code section 65009(b)].
