Interview applicant Christopher Lang and make appointment as appropriate to the Fairfax Climate Action Committee, to fill an unexpired term to 09/30/23.

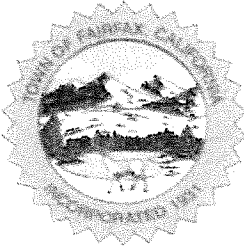
**DISCUSSION**
