Highlights of the September 4, 2019 Town Council Meeting

The Town Council took the following actions:

-- Adopted Proclamations:

- Thanking and commending the Fairfax Planning Commission for their dedication and hard work on Town policies and ordinances.
- Naming September Prostate Cancer Awareness Month
- Congratulating the Community Media Center of Marin on their 10Year Anniversary

-- Authorized the Town Manager to contract, up to \$80,000, for the repair and/or replacement of a portion of the sidewalks in

downtown. The work on the specific sections of sidewalks along Bolinas Road between Broadway and Elise Lane is scheduled to begin in September. Town staff will work with the Chamber of Commerce to provide advance notices to the affected businesses.

-- Adopted two ordinances, which take effect October 4, 2019, to address commercial cannabis:

- An ordinance establishing zoning standards and restrictions for certain commercial cannabis uses and cannabis cultivation for personal use. The Town only allows adult-use deliveryonly retail businesses and continues to allow medical storefront and delivery operations. The ordinance would establish a maximum of two commercial cannabis businesses at any one time in town. A business can be a combination of any of the allowed uses.
- An ordinance regulating commercial cannabis businesses which establishes the local cannabis business permit approval process.

-- Adopted an ordinance amending local smoking regulations to prohibit the sale of favored tobacco products to include mentholfavored tobacco, all cigar packaging sizes, and pipe/chewing tobacco. This ordinance takes effect September 1, 2020.

-- Introduced an ordinance to establish time limits for incomplete applications and project entitlement approvals. Please note that the introduction of an ordinance is the first of two public meetings required for the Council to adopt an ordinance.

-- Introduced an ordinance regulating single-use foodware to require businesses to use compostable or reusable materials for take-out food.


Presentation on Marin Wildfire Prevention Authority

At the September 4thCouncil meeting, Ross Valley Fire Department/Marin County Fire Chief Jason Weber provided an overview of the Marin Wildfire Prevention Authority (WMFA) initiative that is proposed to be on the March 2020 ballot. Currently, 19 local fire agencies provide fire protection and emergency response services to communities in Marin, but there is no single coordinating agency for wildfire prevention. The Marin Wildfire Prevention Authority would allow local fire agencies and emergency service providers, city and town governments, and county of Marin to work together as a single coordinated Joint Powers Authority (JPA) to develop and implement a comprehensive wildfire prevention and emergency preparedness initiative. Chipper Days

Given the heightened awareness of fire safety, the Town scheduled more "Chipper Day" events (eight) than the previous year (six). Of the eight Chipper Days, three (3) were specifically targeted for neighborhoods that are designated Firewise communities. In 2019, the Town collected over 86 tons (172,000 lbs.) of brush/cuttings from 404 participating households, which is the most tonnage since 2011 when the Town did a town-wide door-to-door pick up of brush/cuttings.

PUBLIC SAFETY What is the PG&E Public Safety Power Shutoff (PSPS)?

In order to keep communities safe, PG&E may need to turn off power during extreme

Sign up for alerts even if you are not a direct customer of PG&E

"How can people in our communities receive notifications of a PG&E Public Safety Power Shutoff if they are not a PG&E customer?" Now anyone can get those notifications by zip code.

You might want to sign up for these non-account holder alerts if:

• Your landlord or property manager is the account holder for your electric service.

- You care for someone who relies on electricity for medical needs, but you are not the PG&E account holder at their address.
- You or your organization provide critical care or services dependent on electricity.
- You may also sign up if you would like to receive PSPS ZIP Code Alerts for an area where you don't have a PG&E account.


