**RECOMMENDATION**

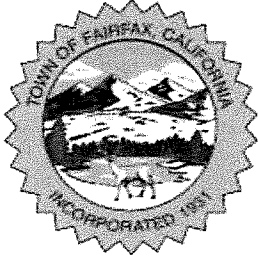
Interview applicant Brad Handel and make appointment as appropriate to the Open Space Committee, to fill an unexpired term to 01/31/21.
