Interview applicant Jonathan Sicroff and make appointment as appropriate to the Fairfax Open Space Committee ("FOSC") to fill a vacancy.

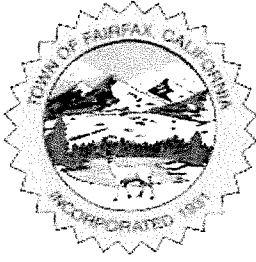
DISCUSSION

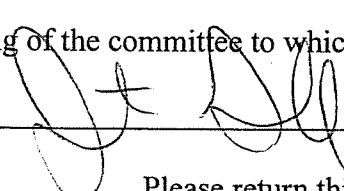
