

**RESOLUTION 19-40**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX, RECITING THE FACT OF THE GENERAL ELECTION HELD ON NOVEMBER 5, 2019, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW**

**WHEREAS**, A General Election was held and conducted in the Town of Fairfax, California, on Tuesday, November 5, 2019, as required by law; and

**WHEREAS**, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

**WHEREAS**, pursuant to Resolution 19-12 and 19-13 of the Town Council of the Town of Fairfax, adopted June 5, 2019, the Marin County Election Department canvassed the returns of the election and has certified those results to this Town Council which results are received, attached and a part hereof as "Exhibit A."

**NOW, THEREFORE**, the Town Council of the Town of Fairfax, California, does resolve, declare, determine, and order as follows:

SECTION 1. That the whole number of ballots cast in the precincts was 2592 for Town Councilmember, 2592 for Town Clerk, 2592 for Town Treasurer, and 2592 for Measure "F", including Absentee and Provisional Ballots;

SECTION 2. That the names of the candidates voted upon at the election and the total number of votes each received were as follows:

SECTION 3. That the number of votes given at each precinct and the number of votes given in the Town for each candidate and for and against Measure "F" were as listed in Exhibit "A" attached.

SECTION 4. That as a result of the election, the Town Council does declare and determine that Renee L. Goddard and Stephanie Hellman received the highest number of votes and were elected as Councilmembers, Michele Gardner received the highest number of

votes and was elected as Town Clerk, and Janet Garvin received the highest number of votes and was elected as Town Treasurer.

SECTION 5. That Measure "F" approving an eleven-year extension of Fairfax's special municipal services tax, was also voted on at the November 5, 2019 election, with the total number of "Yes" votes as 2052 or 80.69%, and the total number of "No" votes as 491 or 19.31%.

SECTION 6. That as a result of the election, the "Yes" votes on Measure "F" received more than the requisite two-thirds vote required and therefore Measure "F" was passed.

SECTION 7. That the Deputy Town Clerk shall enter on the records of the Town Council of the Town, a statement of the result of the election, showing: (1) the whole number of ballots cast in the Town; (2) the offices and the measure voted upon; (3) the number of votes given at each precinct for each candidate and for and against Measure "F"; (4) the total number of votes given for each candidate and for and against Measure "F"; and (5) certification of the passage of Measure "F" by the voters in Ordinance No. 839 attached as "Exhibit B."

SECTION 8. That the Deputy Town Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the Deputy Town Clerk and authenticated; that the Deputy Town Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the Town Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which he or she has been elected.

SECTION 9. That the Deputy Town Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.

The foregoing Resolution was duly introduced and adopted at a regular meeting of the Town Council of the Town of Fairfax held in said Town on the 4th day of December 2019, by the following vote, to wit:

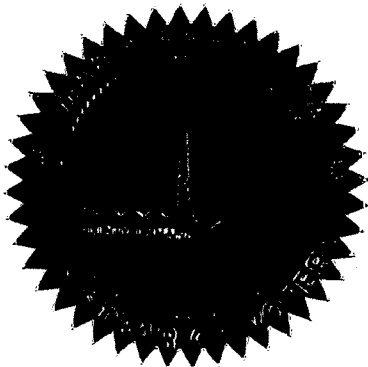

**ORDINANCE NO. 839**

**AN ORDINANCE OF THE TOWN OF FAIRFAX, CALIFORNIA,  
AMENDING CHAPTER 3.20 OF THE FAIRFAX MUNICIPAL CODE AUTHORIZING THE  
LEVY OF A SPECIAL TAX TO FINANCE MUNICIPAL SERVICES**

**THE PEOPLE OF THE TOWN OF FAIRFAX, CALIFORNIA DO HEREBY ORDAIN AS  
FOLLOWS:**

**Section 1:** Section 3.20.020 of Chapter 3.20 of the Fairfax Municipal Code is hereby amended to read as follows:

**§ 3.20.020 SPECIAL SERVICES TAX IMPOSED; RATE.**

A special municipal services tax not exceeding the maximum amounts set forth in this section is imposed on all improved real property within the boundaries of the town:

(A) A special municipal services tax is levied and imposed upon improved residential property at a rate of \$195 in the first year and increasing \$5 annually to a maximum of \$250 per dwelling unit. As used herein the term "dwelling unit" means any building or portion thereof used and/or designed as a separate dwelling accommodation, with cooking, living and sleeping facilities.

(B) A special municipal services tax is levied and imposed upon improved business property at a rate of \$195 in the first year and increasing \$5 annually to a maximum of \$250 for each business occupancy. As used herein, the term "business occupancy" means any portion of a building or structure or other improved real property which is occupied or designed to be occupied by a separate business establishment required to be licensed as such pursuant to Title 5 of this code.

**Section 2:** Section 3.20.080 of Chapter 3.20 of the Fairfax Municipal Code is hereby amended to read as follows:

**§ 3.20.080 TERMINATION OF PROVISIONS.**

This chapter shall be null and void as of 12:00 midnight, June 30, 2031, and shall have no force and effect whatsoever after said time and date. Notwithstanding the previous sentence, § 3.20.060, relating to collection and enforcement of liens or obligations for the special tax previously levied hereunder, shall continue in effect until such time as the collection and enforcement procedures have been completed.

**Section 3:** The appropriations limit of the Town of Fairfax established under Article XIII B, Section 6 of the California Constitution shall be increased by the proceeds received from the special tax imposed by this ordinance. Any future increases in the appropriations limit shall be approved by a majority vote of the voters voting thereon.

**Section 4:** If any provision of this ordinance or the application thereof to any person or circumstances is held invalid or unconstitutional by any court of competent jurisdiction, such invalidity



or unconstitutionality shall not affect any other provision or applications, and to this end the provisions of this ordinance are declared to be severable. The Town Council, and the electorate by referendum, do hereby declare that they would have adopted this ordinance and each section, subsection, sentence, clause, phrase, part or portion thereof, irrespective of the fact that any one or more sections, subsections, clauses, phrases, parts or portions thereof, be declared invalid or unconstitutional.

**Section 5:** This ordinance shall be adopted and become effective only if approved by two-thirds of the voters voting thereon, at an election to be held on November 5, 2019.

**Section 6:** The Mayor is hereby authorized to attest to the adoption of this ordinance by signing where indicated below.
