

RESOLUTION 18-37

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX, RECITING THE FACT OF THE GENERAL ELECTION HELD ON NOVEMBER 6, 2018, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW


- WHEREAS,** A Consolidated General and Special Election was held and conducted in the Town of Fairfax, California, on Tuesday, November 6, 2018, as required by law; and
- WHEREAS,** notice of the election was given in the time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and
- WHEREAS,** pursuant to Resolution 18-25 of the Town Council of the Town of Fairfax, adopted on the 18th day of July 2018, the County Election Department canvassed the returns of the election and has certified those results to this Town Council, which results are received, attached and a part hereof as Exhibit "A."
- NOW, THEREFORE,** the Town Council of the Town of Fairfax, California, does resolve, declare, determine, and order as follows:
- SECTION 1. That the whole number of ballots cast in the precincts was 2818 for Measure "O," including Absentee and Provisional Ballots.
- SECTION 2. That the number of votes given at each precinct and the number of votes given in the Town for said measure is as listed in Exhibit "A" attached.
- SECTION 3. That Measure "O," continuing the special tax for paramedic services for four years in the amount of \$79.50 in the first year and increasing \$4 annually to a maximum of \$91.50 per taxable living unit, or per 1,500 square feet of structure on a developed parcel in nonresidential use, which will annually raise approximately \$296,000 beginning in year one, and increasing the appropriations limit by the amount of said tax, was voted on at the November 6, 2018 election, with the total number of "Yes" votes as 3134 or 77.27%, and the total number of "No" votes as 922 or 22.73%.
- SECTION 4. That as a result of the election, the "Yes" votes on Measure "O" received more than the requisite 2/3 majority vote required by the California Constitution and therefore Measure "O" was passed.

SECTION 5. The Town Clerk shall enter on the records of the Town Council of the Town, a statement of the result of the election, showing: (1) the whole number of ballots cast in the Town; (2) the measure voted upon; (3) the number of votes given at each precinct for and against the measure; and (4) the total number of votes given for the measure; and (5) certification of the passage of Measure "O" by the voters attached hereto as Exhibit "A."

SECTION 8. That the Town Clerk shall immediately certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.


The foregoing Resolution was duly introduced and adopted at a regular meeting of the Town Council of the Town of Fairfax held in said Town on the 5th day of December 2018, by the following vote, to wit:

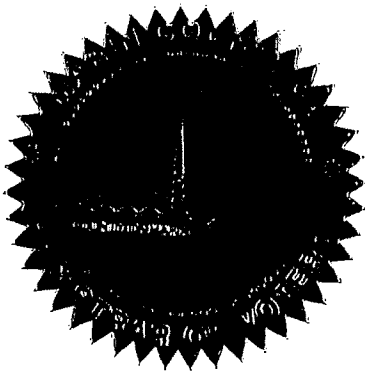
