SCOPE OF SERVICES:

Architectural Additional Phase II Services

Expanded scope of work for full seismic upgrade instead of the foundation only design necessitated an increased fee for architectural and consultant services. Our fee includes architect's coordination with project consultants consisting of structural, archaeology, civil, mechanical/plumbing/electrical, and historical preservation disciplines. Other services include responding to FEMA and Cal OES comments and representation at project meetings. Fee also includes preparing cost estimates for FEMA Budget information.

Services are through issuance of bid award. Construction Administration services shall be under separate agreement.
