All Town of Fairfax public meetings will be conducted using teleconferencing or other electronic means consistent with the State of California Executive Order N-29-20 dated March 17, 2020, regarding the COVID-19 pandemic. The Town of Fairfax is not offering an in-person meeting location for the public until further notice. How to observe and participate in the meeting: In accordance with Executive Order N-29-20, the public may view the November 16, 2020, Tree Committee meeting only via Zoom webinar.

Join using a desktop or mobile application

- Before joining a Zoom session on a computer or mobile device, [download the Zoom app](#). Otherwise, you will be prompted to download and install Zoom when you click a join link (this can take several minutes and delay your access to a session).
- Once the app is downloaded, click the session link
- When you join a Zoom session you'll be prompted to join with either computer or phone audio. You will also be able to select the audio / video input and output once you are in the meeting. Select telephone only if you do not have a microphone on your computer. To hear audio with the telephone option, you must also call into the session via phone.

Leave meeting: Click "Leave meeting" to leave the webinar at any time. If you leave, you can rejoin the webinar, as long as the host has not locked the webinar or the webinar has ended.

MEMBERS OF THE PUBLIC MAY PROVIDE COMMENT.

Communicate with the Host and Panelist during the public comment portion of the meeting.

As an online attendee, you can participate in the meeting during the public comment period by virtually raising your hand. The chair will recognize you.

- click the button labeled "**Raise Hand**" in the middle at the bottom of the screen
- Your virtual hand is now raised. Lower it by clicking the same button.
- If you are calling in via telephone, press *9 to raise your hand.
press *6 to unmute yourself.

- Comments received by email or web form prior to the close of the public comment period for an item will be read into the record, subject to the same 3-minute time limit as in-person spoken comments, which is approximately 400 words. Comments received after the agenda item is heard but before the close of the meeting will be included as a part of the record of the meeting, but will not be read aloud. Comments will be read verbatim, so please introduce yourself.

Prior to the meeting, as always, members of the public may submit written comments to the Tree Committee. These comments will be a part of the meeting record, but they will not be read out loud at the meeting. Notice is hereby given that Monday, November 16, 2020, at 6:00 p.m. or as soon thereafter as the matter may be heard, the Fairfax Tree Committee will hold a public hearing on each of the projects described below via Zoom Webinar.
