TOWN COUNCIL NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that on **Wednesday, December 16, 2020**, at **7:00 pm** or as soon thereafter as the matter may be heard, the Fairfax Town Council will hold a public hearing on the matter described below via teleconference consistent with State of California Executive Order N-29-20. There will not be an in-person meeting location.

Description: Consider the adoption of an increase to garbage (solid waste and recycling) fees, to be effective January 1, 2021, based on the new rate setting methodology adopted in 2020.

Any person interested may appear and be heard as to whether the proposed rates and charges are discriminatory or excessive, or will not be sufficient under Government Code Section 54515, or will not comply with any other provision of Chapter 6 of Part 1 of Division 2 of the Government Code, or on any other matter relating to said proposed increase or the rates or charges proposed therein. This action is exempt from the California Environmental Quality Act per 14 CCR 15061(b)(3), as it can be shown with certainty that the action will have no adverse significant effect on the environment.
