

RESOLUTION 20-37

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX
RECITING THE FACT OF THE GENERAL ELECTION HELD ON NOVEMBER 3, 2020,
DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW**

WHEREAS, A General Election was held and conducted in the Town of Fairfax, California, on Tuesday, November 3, 2020, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolution 20-20 of the Town Council of the Town of Fairfax, adopted June 3, 2020, the Marin County Election Department canvassed the returns of the election and has certified those results to this Town Council which results are received, attached and a part hereof as "Exhibit A."

NOW, THEREFORE, the Town Council of the Town of Fairfax, California, does resolve, declare, determine, and order as follows:

SECTION 1. That the whole number of ballots cast in the precincts was 5485 for Town Councilmember, including Vote-by-Mail and Provisional Ballots.

SECTION 2. That the names of the candidates voted upon at the election and the total number of votes each received were as follows:

Chance Cutrano	3,320
Barbara Coler	2,914
Bruce Ackerman	2,277
John Reed	1,965
Joe McGarry	1,474

SECTION 3. That the number of votes given at each precinct and the number of votes given in the Town for each candidate were as listed in Exhibit "A" attached.

SECTION 4. That as a result of the election, the Town Council does declare and determine that Chance Cutrano, Barbara Coler, and Bruce Ackerman received the highest number of votes and were elected as Councilmembers.

SECTION 7. That the Town Clerk shall enter on the records of the Town Council of the Town, a statement of the result of the election, showing: (1) the whole number of ballots cast in the Town; (2) the office voted upon; (3) the number of votes given at each


precinct for each candidate; and (4) the total number of votes given for each candidate.

SECTION 8. That the Town Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the Town Clerk and authenticated; that the Town Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the Town Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which he or she has been elected.


SECTION 9. That the Town Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.

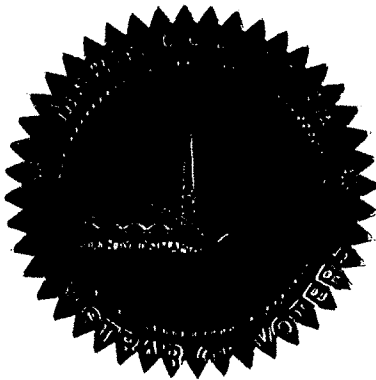
