6. DISCUSSION WITH GARRETT TOY AND DANA ARMANINO REGARDING DIFFERENT APPROACHES TOWARD BUILDING ELECTRIFICATION

- Dana Armanino gave a presentation outlining three main options available to jurisdictions who want to adopt an ordinance for building electrification:
 - o Option 1 Adopt County template Electric Preferred ordinance
 - Need to demonstrate to CEC requirements are cost-effective
 - All documents for Council and CEC are available from County
 - Would need to be updated with next CA Building Code Update in 2023 (updates are done every three years)

- Option 2 Adopt an All-Electric Ordinance
 - Example/Template: San Francisco's Ordinance adopted in 2020
 - Justification for adoption is health and safety
 - Does not require CEC cost effective justification
 - Potential legal implications
- Opportunity Now Promote Electrify Marin to all residents
 - County/BAAQMD sponsored rebate program
 - Rebates available for replacement of natural gas equipment with high efficiency electric units
- Discussion followed to clarify each option, hear what other local jurisdictions are adopting, understand potential challenges, such as lawsuits, pushback from community, defining remodel trigger point.
- M/S: Hellman/Lang, motion to adopt Option 1.
- Upon further discussion; Hellman/Lang motion withdrawn; more discussion of Option 2, with the health
 and safety approach, which, once adopted, is complete, no need for further studies or updates to match CA
 updates.
- Bruce recommended phased approach: New construction first; then significant remodels; then replacement of existing appliances. Allows for time to engage community. Also noted: heating for home and water is biggest use of natural gas; ranges, dryers, etc. have less impact overall.
- Outcome: current CAC Resolution to Council stands (recommending all-electric for new construction)
- Community Engagement subcommittee will play key role in promoting strategy
