**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX  
DESIGNATING THE WESTERN PORTION OF THE PAVILION/BANK STREET PARKING  
LOT FOR USE AS A TEMPORARY SKATE/SCOOTER PARK AND ESTABLISHING THE  
RULES AND REGULATIONS FOR THE TEMPORARY SKATE/SCOOTER PARK**

**WHEREAS**, Sections 10.28.020, “Designated Skate Park Area”, and 10.28.030, “Safety Equipment Required”, were adopted on March 3, 2021, and added to Chapter 10.28 of the Fairfax Municipal Code, Entitled “Skateboards”; and

**WHEREAS**, pursuant to Section 10.28.020, the Town Council desires to designate a portion of the Pavilion/Bank Street public parking lot for the use of non-motorized skateboards, scooters, inline skates, and roller skates; and

**WHEREAS**, pursuant to Section 10.28.030, the Town Council desires to set rules and regulations for the skate park area,

**NOW, THEREFORE, BE IT HEREBY RESOLVED**, by the Town Council of the Town of Fairfax as follows:

**Section 1.** The western portion of the Pavilion/Bank Street public parking lot, as depicted approximately on the map attached hereto as Exhibit A, is hereby designated for the use of non-motorized skateboards, scooters, inline skates, and roller skates.

**Section 2.** The rules and regulations attached hereto as Exhibit B are hereby established for the skate park area designated hereinabove.

**Section 3.** The Town Manager is authorized to make to make modifications, from time to time, to the Park rules and regulations as required by State law or as recommended by our insurance pool.

The foregoing Resolution was duly passed and adopted at a Regular Meeting of the Town Council of the Town of Fairfax held in said Town on the 3<sup>rd</sup> day of March 2021, by the following vote, to wit:

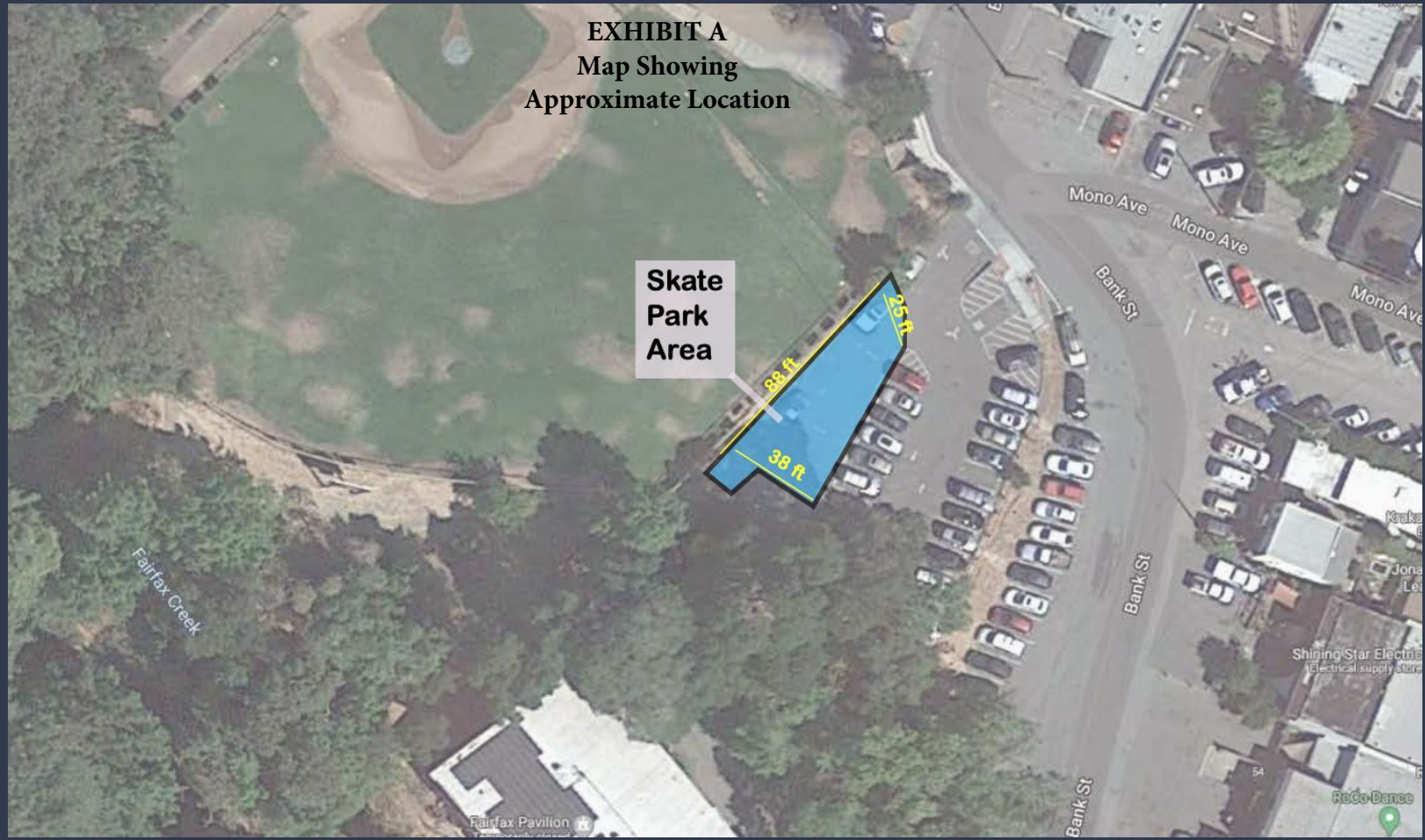

**Skateboard Park Rules and Regulations**

1. All users are required to wear helmets, kneepads, and elbow pads. Users who do not comply will be subject to a citation under Ordinance (specify number).
2. Non-motorized /non-electric skateboards, scooters, inline/roller skates only. No bicycles, no motorized devices, or other wheeled devices.
3. No tobacco, drugs, or alcohol on premises.
4. Park hours of operation: 9:00am to sunset.
5. Please keep noise to a minimum.
6. Keep food and drink off the skating surface.
7. No glass, stones, or similar items in or around the skating area.
- ~~7.8.~~ No chairs, or other seating in the parking lot or skating area.
- ~~8.9.~~ Please put trash in designated trash receptacles.
- ~~9.10.~~ No skateboarding when wet or rainy.
- ~~10.11.~~ No loitering.
- ~~11.12.~~ No trespassing.
- ~~12.13.~~ No graffiti.
- ~~13.14.~~ Additional obstacles or other materials (ramps, jumps) may not be brought into the park.
- ~~14.15.~~ Do not use the facility if any hazardous condition arises. Report any damage and/or hazardous conditions to the Town.
- ~~15.16.~~ No amplified music or organized events allowed without prior written approval from the Town
- ~~16.17.~~ Anyone under the age of 12 must be accompanied by a parent or guardian.
- ~~17.18.~~ In case of emergency, call 911.

**Warning:** Skateboarding is a hazardous recreational activity. Use of this facility may result in death, paralysis, brain damage, broken bones, or other serious injury. Any use is at your own risk. The city does not assume any responsibility for injuries. (Government Code Section 831.7)
