Join using a desktop or mobile application

- Before joining a Zoom session on a computer or mobile device, <u>download the Zoom app</u>. Otherwise, you will be prompted to download and install Zoom when you click a join link (this can take several minutes and delay your access to a session).
- Once the app is downloaded, click the session link i
- When you join a Zoom session you'll be prompted to join with either computer or phone audio. You will also be able to select the audio / video input and output once you are in the meeting. Select telephone only if you do not have a microphone on your computer. To hear audio with the telephone option, you must also call into the session via phone.

Leave meeting: Click "Leave meeting" to leave the webinar at any time. If you leave, you can rejoin the webinar, as long as the host has not locked the webinar or the webinar has ended.

Members of the public may provide public comment during the meeting using ONE of the following options:

• Using the Public Comment form directly below the live stream meeting on the on the town website.
