- Attended Marin County Mayors & Councilmembers Legislative Committee (June 28) –In May the Committee took oppose positions on several housing bills (yet there was an error and no letters were sent at that time), so on June 28 the Committee voted to send oppose letters on the following: AB 215 (Chui) – creates requirements for mid-cycle consultations with HCD for time consuming process & allows HCD to dictate a city's/county's housing policies; AB 989 – creates a new Board within HCD to hear appeals on locals projects & allows them to issue orders to cities/counties; AB 9 – allows up to 6 units on lots (have sent two oppose letters to date, will send another oppose letter to the Appropriations Committee); AB 1401 – limits parking requirements to ~zero. In June again took support positions on two bills where letters were not sent after the May 2021 meeting: AB 14 (Aguilar-Curry) for broadband in underserved communities and removes sunset for CASF funding; AB 897 – allows for regional climate networks. Committee also voted on support letters to be sent on SB 60 – increases maximum fines for short term rental violations; SB 15 – provides incentives for local governments to rezone idle retail sites. Committee also voted to send letter on AB 41 re: broadband infrastructure supporting the mapping of broadband statewide by CA PUC but expressing concerns re: micro-trenching for fiber which may impact local control. Last day for bills to be heard in Policy Committees is July 14.
