

# TOWN OF FAIRFAX SPECIAL MEETING STAFF REPORT August 4, 2021

**SUBJECT:** Interview two applicants and consider appointment to the Marin County

Commission on Aging

#### RECOMMENDATION

1. Interview applicants Zev Rattet and Josaphine Buennagel.

2. Consider and appoint one applicant to the Marin County Commission on Aging, for a three-year term to expire June 30, 2024.

### **DISCUSSION**

There is currently a vacancy for the Fairfax representative to the Marin County Commission on Aging, due to the expiration of Jody Timms' term on June 30, 2021. There are two applicants for the position, Fairfax residents Josaphine Buennagel and Zev Rattet. Staff recommends that the Council interview each applicant, take public comment, and then consider and make an appointment.

The Marin County Commission on Aging is a federally mandated advisory council. The mission of the 23-member commission is to promote the dignity, independence, and quality of life of older persons through advocacy, information, programs, and services. It serves in an advisory capacity to the Marin County Board of Supervisors and works closely with the County's Office of Aging and Adult Services on behalf of Marin's older adults, persons with disabilities and family caregivers.

Commissioners are appointed to three-year terms by either the Board of Supervisors or the 11 incorporated towns and cities in Marin, with two additional members being elected to serve in the California Senior Legislature. Eligibility is open to local residents 18 years and over.
