Councilmember Coler

- Attended Countywide HUD Priority Setting Committee (Sep 2) received a report on HUD CDBG and Home audit (3 findings but no concerns); reviewed and recommended allocation of the State's Permanent Local Housing Allocation (PLHA, \$725K non-competitive grants awarded countywide) recommended even 1/3 spilt for each: CLAM's West Marin Coast Guard Housing; Homeward Bound's Mill Street & their HUD parcel veteran workforce housing. The Committee strongly requested that as this funding is for the entire County, next year there should be outreach early to all communities and the Committee members. Also received presentations on AB 686 Affirmatively Furthering Fair Housing and the Restrictive Covenants Program by L. Darby, Social Equity Coordinator.
- Attended MCE Clean Energy Executive Committee (Sep 3) acknowledged clean audit for prior fiscal year; approved recommendation to MCE Board to extend the Cares Credit program though the end of MCE's fiscal year (so 1/1/2022 3/30/2022) for eligible entities and continue outreach ~33,000 residents enrolled, saves \$10/month; 881 small businesses (SB) enrolled, saves ~\$22/month); customer programs reported that CPUC has carved out 33% of their energy efficiency program for equity/market support which is not held to the cost effectiveness standard of the rest of the EE portfolio (good news, MCE has been advocating for this change) this fits with MCE's equity programs of SB assistance; home energy savings; electrification workforce development (trainings with 4 paid interns for disadvantaged communities)
- Met with MCE Clean Energy Policy/Legal staff re: biomass issues (Sep 7).
- Attended Fairfax Affordable Housing Committee meeting (Sep 8) housing element (HE): brainstorming draft list of potential sites for discussion purposes only; overview of the "missing middle" housing concepts; outreach suggestions; discussion on AB 686 application to the HE.
- MCE Board meeting was not held in Sep (all day Board Retreat is Oct 7 by Zoom, 9-3).
- Attended Ad Hoc LAFCO committee meeting RE: working groups (Oct 10)

- Met with Fairfax Interim Town Manager several times on transition matters (Sep 7, 14, 21, 28, Oct 5).
- Attended Marin Wildfire Prevention Authority Board meeting (Sep 16) Approved MWPA Social Media Policy; approved RFQ issuance for wildfire evacuation/ingress/egress risk assessment (will be the 1st of its kind) acknowledged environmental compliance/project approvals for two Projects Marin Valley Goat Grazing & and a LRAD siren installation in Mill Valley; approved 1st amendment to Fire Aside agreement to allow integration of defensible space grant programs to be integrated within the software (side note: EO Brown reported that MWPA did not receive its \$1.8M for 3 year grant proposal for AFN/low income senior grant program but MWPA has \$500K allocated of its funds to fully fund the program this FY, ETA Nov 2021 launch); received extensive reporting of FireSafe Marin on their many activities/accomplishments funded by MWPA, see https://firesafemarin.org/programs/, note: FireSafe Marin no longer uses webinars, they now have live programs airing on Marin TV (CMCM).
- Attended Town Picnic tabled for the Fairfax Open Space Committee (Sep 19)
- Attended Community Media Center of Marin Board meeting (Sep 23) Staff finished the San Anselmo and Larkspur upgrades to HD. The Tiburon and Ross new installations are also finished. Fairfax and San Rafael Zoom Hybrid installations are largely finished; with MMWD's install next week. Corte Madera is moving into temporary offices while their city hall is demolished/rebuilt – staff will move all equipment into their temporary space. Lorenzo Jones started as new Board member representing the business community.
- Attended Fairfax Age Friendly Task Force meeting (Sep 24) Library rep participated; discussed CA Chronicles & iPhone/Android training upcoming in Oct; small free lending libraries setup at Victory Village and Bennett House. Planning for 90 and over annual celebration to be held November 13 as with last year due to Covid, we will deliver gift baskets to participants (all those 90 or over will receive a Mayor's certificate by mail) 54 on our current list.
- Marin County Mayors & Councilmembers Legislative Committee (Was scheduled for Sep 27 - Meeting was not held, cancelled due to staffing issues on 9/25) - Coler Legis. update: the Governor signed into law 3 housing bills: SB8 (extends the 2019 Housing Crisis Act sunset from 2025 to 2030 - accelerates the approval process for housing projects, curtails local governments' ability to downzone and limits fee increases on housing applications), SB9 (allows a single family residential lot to be split and allows duplexes with ADUs, so up to 4 units total per site), and SB10 (provides that local agencies may adopt an ordinance to allow up to 10 dwelling units on any parcel, at a height specified in the ordinance, if the parcel is within a transit-rich area or urban infill site). He also signed an urgency housing bill AB 1174 - makes changes to the existing streamlined, ministerial approval process for housing development in jurisdictions that have not yet made enough progress towards their allocation of their regional housing needs. To date, he has signed 31 housing bills which his website states "Governor Newsom has signed 31 affordable housing bills focused on cutting red tape and holding cities accountable for providing their fair share of housing." https://www.gov.ca.gov/2021/09/28/governor-newsom-signs-legislation-to-increaseaffordable-housing-supply-and-strengthen-accountability-highlights-comprehensive-strategyto-tackle-housing-crisis/. He also signed urgency legislation AB 361 which allow teleconferences (e.g., ZOOM) for legislative bodies subject to the Brown Act to continue (during emergencies – Covid, wildfires, etc.); the Governor's Executive Order ends 9/30/2021. The Governor has until Oct 10 to sign or veto bills.
- MCCMC LEGISLATIVE COMMITTEE SCOPE OF ADVOCACY: Fiscal Protection: protect city revenues from state Local Control: support legislation that enhances local control of

resources to provide services while supporting regional co-operation. Oppose unfunded mandates and preemption of local authority and control of land use Transportation Investment: promote stable transportation finance structure for state and local government. Multimodal, enhancing livable communities Housing/Land use: protect local government land use authority. Oppose punitive housing legislation, and legislation that restricts or reduces local discretion on land use decisions. Other legislation can be recommended to MCCMC at a regular meeting.

- Attended SURJ (Standing Up for Racial Justice) cohort 5 workshop (Sep 27 & premeeting Sep 21) – homework - discussed Letter from a Birmingham Jail by MLK and Dick Cavett interview with James Baldwin. Challenges to moving the needle on racial justice and individual action steps.
- Attended Marin County Mayors & Councilmembers meeting (Sep 29) Speakers: Katie Rice & Liz Darby – Marin County's Restrictive Covenants Project; Primary speakers were Linda Jackson, from the Aging Action Initiative, and Lee Pullen, Marin Co. Commission on Aging, who will provide updates on the Aging Action Initiative, age-friendly and other plans, and ageism.
- Attended Countywide HUD Priority Setting Committee (Sep 30) Appoint three Countywide Priority Setting Community Committee members representing protected classes for: Fairfax, Ross, San Anselmo one applicant only is incumbent Phillip "PJ" Feffer; Belvedere, Mill Valley, Sausalito, Tiburon, and adjacent unincorporated communities, including Marin City and Tam Valley 5 applicants; and a Countywide, at-large member one applicant only is incumbent Cathy Cortez; discussed the upcoming funding cycle priority review; the Federal Lead Safe Housing Rule and implications for projects funded through the Federal Grants program.
- Attended MCE Executive Committee meeting (Oct 1) MCE annual retreat is Oct. 7, 9-3 on Zoom.

- Ross Valley Paramedic Authority (RVPA). Received an update on the closure of the Ross Fire Station (Station 18) and the potential opportunities for other service models and general impact on ambulance service provided from that station.
