SUBJECT: Interview applicant Mitch Greer and consider his appointment to the Climate Action Committee

RECOMMENDATION

Interview applicant Mitch Greer and consider his appointment to the Climate Action Committee for a full 4-year term to October 30, 2025.

DISCUSSION

There are currently up to 4 vacancies on the Climate Action Committee ("CAC"). One application has been received (attached) from Fairfax resident Mitch Greer, who has attended at least one CAC meeting.

The CAC is comprised of at least seven and no more than thirteen members, who serve fouryear terms. Members must be residents of the Town of Fairfax. The Committee was established to create and implement a Climate Action Plan, per the Conservation Element of the adopted 2010-2030 General Plan.
