- Participated in Town Manager candidate interviews
- Attended Community Media Center of Marin (CMCM) Board meeting (Nov 4) Three new Board members were announced – Nicole Cruz representing College of Marin; 2 open seats for Board members election results – Bruce Bagnoli was reelected (he is Chair and a Founding member) & Mariposa de Los Angeles (long time CMCM member) was elected to fill the seat vacated by the passing of Jim Geraghty. Also reviewed the Annual Report for FY 20/21 to be submitted to MGSA.
- Attended Countywide HUD Community Development Block Grant Committee (Nov 4) Committee approved funding priorities for the public services projects; housing and community infrastructure/CIP will remain the same priorities (applications will be open Jan 3 -24; workshop Feb 24). Also discussed HOME-ARP funding that will be \$2.9M – largely to be spent for qualified pop. - homeless; at risk of homelessness; fleeing domestic violence, human trafficking; others with housing instability. To be spent on rental housing; rental assistance; supportive services; non-congregate shelter. County staff will work bring to the Committee for allocation after working with the Continuum of Care group (about 6 months – all funds must be spent by Sep 2030).
- Attended MCE Clean Energy Executive Committee meeting (Nov 5) Voted to recommend Assemblymember Cecilia Aguiar-Curry for the MCE Climate Action Leadership Award to the full Board; voted to recommend proposed MCE Rate Adjustment to the full Board – needed to increase rates due to the significant increases in energy and resource adequacy costs, if approved by the Board, after a 30-day public comment period, will still be a 2% discount from PGE rates.
- Attended Town of Fairfax Affordable Housing Committee meeting (Nov 9) Discussed groups to target outreach/focus group discussions; discussion of upcoming November 20 housing element workshop.
- Met with Interim Town Manager several times on transition and other Town matters (Nov 9, 16, 23, 30)
- Age Friendly Task Force 90 and better celebration (Nov 13) This is the 4th annual event, due to uncertainty regarding Covid as with 2020 individual gift baskets were delivered rather than a lunch as with the first two events; Coler and others on Age Friendly delivered gift baskets to the participants.
- Took tour of Marin Sanitary organic waste diversion (Nov 15).
- Met with Executive Officer Brown of the Marin Wildfire Prevention Authority (Nov 15).
- Attended Marin Wildfire Prevention Authority Board meeting (Nov 18) submitted prior to meeting being held; primary topic is the proposed MCE Rate Adjustment.

  transportation finance structure for state and local government. Multimodal, enhancing livable
  communities Housing/Land use: protect local government land use authority. Oppose punitive
  housing legislation, and legislation that restricts or reduces local discretion on land use
  decisions. Other legislation can be recommended to MCCMC at a regular meeting.
