- Attended Marin Wildfire Prevention Authority (MWPA) Board meeting (Jan 20) Received workplan progress report & that Operations Committee is developing next FY workplan; adopted MWPA objectives document (part of strategic planning efforts); approved job description and salary range for Management Analyst (recruitment to begin soon) position; adopted guidelines for contractor for grants specialist; reviewed FireSafe Marin's report and annual chipper day report; Operations Committee Fire Chief White (SR) is now Chair & Dan Schwartz remains Vice Chair; education session held on MWPA's CEQA compliance strategy by MWPA's CEQA Counsel and Environmental Consulting firm rep.

- Civic Center Oath of office for Supervisor succession in emergency (Jan 24).
- Marin County Mayors & Councilmembers Legislative Committee (Jan 24) Governor's proposed budget highlights: nearly \$46B surplus projected; \$286.4B budget rebuild reserves and strengthen economic support for families and businesses; most to be spent on one-time investments. State may exceed the Gann Limit which would require taxpayer rebates and increased education spending. It is expected that there will be maneuvers to expend the excess revenue (to eliminate the possible exceedance of the Gann Limit) which may include paying down additional debt, invest in infrastructure, and providing discretionary funding to local governments.

- MCCMC LEGISLATIVE COMMITTEE SCOPE OF ADVOCACY: Fiscal Protection: protect city
 revenues from state Local Control: support legislation that enhances local control of resources
 to provide services while supporting regional co-operation. Oppose unfunded mandates and
 preemption of local authority and control of land use Transportation Investment: promote stable
 transportation finance structure for state and local government. Multimodal, enhancing livable
 communities Housing/Land use: protect local government land use authority. Oppose punitive
 housing legislation, and legislation that restricts or reduces local discretion on land use
 decisions. Other legislation can be recommended to MCCMC at a regular meeting.
