SUBJECT: Adopt a Resolution Continuing Expenditures and Revenues in Accordance with the FY 2021-22 Town Budget and Continuing the FY 2022-23 Town Budget Adoption

RECOMMENDATION

Adopt a resolution continuing expenditures and revenues in accordance with the Fiscal Year 2021-22 Town Budget and continuing the Fiscal Year 2022-23 budget adoption process.

DISCUSSION

This action allows the Town to continue its operations after the start of the new fiscal year (July 1, 2022) without an approved FY2022-21 budget. While the Town would prefer to adopt its annual budget prior to the start of the new fiscal year, the Town typically adopts a resolution to allow the Town to continue its operations until the new budget is adopted.

On May 13, 2022, the Council held a workshop on the proposed FY2022-23 operating and capital budget. Later this evening, the Council will conduct a public hearing on the proposed FY2022-23 budget.

Staff anticipates the Council will consider the adoption of the FY2022-23 budget at its next regular meeting, July 6, 2022.

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX
CONTINUING EXPENDITURES AND REVENUES IN ACCORDANCE
WITH THE FISCAL YEAR 2021-2022 TOWN BUDGET AND
CONTINUING THE FISCAL YEAR 2022-2023 BUDGET ADOPTION**

WHEREAS, the Town of Fairfax operates on a July 1st to June 30th Fiscal Year;
and

WHEREAS, it is prudent for the Town Council to adopt a budget by July 1st to
authorize expenditures for the ensuing year; and

WHEREAS, the Town staff is preparing a draft budget for Fiscal Year 2022-
2023 and the Town Council held a budget workshop on May 13, 2022, and held a
public hearing for the budget on June 1, 2022, to provide input into the final budget
document;

NOW, THEREFORE, BE IT RESOLVED, that the Town of Fairfax hereby
authorizes expenditures to be charged and revenues to be credited to Fiscal Year
2021-2022, as appropriate, until such time that the Fiscal Year 2022-2023 budget is
adopted;

AND BE IT FURTHER RESOLVED, Town staff is hereby authorized to continue
to pay normal operating expenditures from each Town fund as appropriate.
