Phasing Out Gas-Powered Landscape Equipment

- Recommendation: Include all gaspowered landscape equipment within the scope of the ordinance
 - With some exemptions provided
- Targeted outreach conducted with local landscapers
- Costs of electric landscape equipment comparable to gaspowered equipment
- Performance is also equivalent, if not better, than gas-powered equipment
- Budget \$27,000 to replace Townowned gas-powered equipment

Trade-in and Rebate Program

- Recommendation: Set up a trade-in and rebate program with Fairfax Lumber & Hardware
- Trade-in and rebate program modeled off of San Anselmo's program for leaf blowers with some modifications
 - Fairfax Lumber & Hardware is supportive and able to host the program
- Rebate program based on equity and frequency of usage
- Budget \$10,000 for rebate program

A 50% discount for up to two extra batteries could be provided to commercial landscapers that purchase at least one of the equipment listed in the table above, not to exceed \$500 in total for the batteries. Alternatively, commercial landscapers could receive a 50% discount on a commercial backpack battery, not to exceed \$680.

Enforcement and Education

- Recommendation: Stagger the compliance dates for the ordinance
 - January 1, 2023 Residents and Town staff
 - January 1, 2025 Landscapers
- Climate Action Committee members and staff would educate the community about the ordinance prior to the compliance dates
- Enforcement escalation:
 - First six months after compliance date Warning letters
 - Post-six-month period \$100 fine, online class, or proof of purchase of electric equipment
 - Increased fines for subsequent violations
