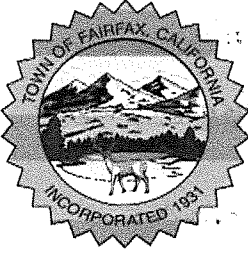
DISCUSSION
