**NOTICE OF ELECTION AND
NOTICE OF TIME WITHIN WHICH ARGUMENTS FOR OR AGAINST
A MEASURE MAY BE SUBMITTED TO THE TOWN CLERK**

NOTICE IS HEREBY GIVEN that a general municipal election will be held in the Town of Fairfax on Tuesday, November 8, 2022, for the following offices and measure:

Two (2) members of the Town Council of the Town of Fairfax, each to serve for a term of four (4) years; and

One (1) Town Clerk for a term of four (4) years; and

One (1) Town Treasurer for a term of four (4) years.

<i>"To maintain 9-1-1 emergency response times and the number of on-duty paramedics to respond to accidents/medical emergencies, shall the measure continuing the paramedic services special tax for four years at an increased annual amount of \$94.50 per residence and per 1,500 square feet of non-residential floor area for fiscal years 2023-24, and thereafter increased \$3 per year up to \$103.50, generating approximately \$353,000 annually for local paramedic services be adopted?"</i>	YES

NOTICE IS FURTHER GIVEN that direct arguments for or against said measure shall not exceed 300 words in length and shall be submitted to the Town Clerk's office, 142 Bolinas Road, Fairfax, California, not later than 5:00 p.m. on Friday, August 19, 2022. The Town Council or any member(s) authorized by it, or any bona fide association of citizens, or any individual voter, or any combination of such associations and voters may submit arguments.

NOTICE IS FURTHER GIVEN that direct arguments for or against said measure may be changed or withdrawn prior to and including Friday, August 19, 2022, until 5:00 p.m. and that, when the Town Clerk has selected the direct arguments for and against said measure which will be printed and distributed to the voters, the Town Clerk shall send copies of the argument in favor to the authors of the argument against and copies of the argument against to the authors of the argument in favor.

NOTICE IS FURTHER GIVEN that the Town Council has determined that the authors may prepare and submit rebuttal arguments not exceeding 250 words. Rebuttal arguments must be filed with the Town Clerk no later than 5:00 p.m. on Monday, August 29, 2022.

A Ballot Measure Argument Signature Form available from the Town Clerk's office must accompany all direct arguments and rebuttal arguments. For information please contact the Town Clerk at (415) 453-1584 or mgardner@townoffairfax.org.

All materials pertaining to the measure will be available for public examination for ten (10) days from the last date of filing.

If no one or only one person is nominated for an elective office, appointment to the elective office may be made as prescribed by Section 10229, Elections Code of the State of California.

The polls will be open between the hours of 7:00 a.m. and 8:00 p.m.
