Appoint a councilmember to the Housing Element ad hoc subcommittee to replace outgoing Councilmember Goddard.

#### DISCUSSION

Councilmembers Coler and Goddard were appointed to the Housing Element ad hoc subcommittee.

Due to the decision of Councilmember Goddard not to run in the upcoming (November) election, and the need for the Housing Element subcommittee to continue into 2023, Councilmember Goddard is stepping down from the subcommittee. She believes it would be beneficial to appoint a new member, in the interest of continuity. As shown in the attached Draft Timeline, the project is anticipated to go beyond the November 2022 election.
