### **RECOMMENDATION**

## **DISCUSSION**

There are currently up to 8 vacancies on the Climate Action Committee ("CAC"). One application has been received. The attached application is from Fairfax resident Kelly Newman, who has attended at least one CAC meeting.

The CAC is comprised of at least seven and no more than thirteen members, who serve fouryear terms. Members must be residents of the Town of Fairfax. The Committee was established to create and implement the Climate Action Plan, per the Conservation Element of the adopted 2010-2030 General Plan.

# Please describe your relevant work/life experience or background for the board/commission you are applying for:

I have worked in science and education for decades. I did environmental education for the Marine Mammal Center, the Otter Project's MPA Watch, the Alameda County Resource Conservation District, Calif. State Parks, and The Marine Science Institute. I did research on ship noise at the Rosential School of Marine and Atmospheric Science, and killer whale research at the University of Alaska, SFSU, and UCSC. I was also a volunteer for Food and Water Watch, where we campaigned against Fracking and GMO foods. I did outreach and tabling for 350.0rg in South Florida, promoting sustainable energy practices. I helped Greenpeace look for whales in proposed drill sites in the Arctic. More locally, I am a volunteer for the Marin Watershed District and worked with SF water and sewer on storm drain education/cleanups. I have taught and done marine research for most of my career, and have the perspective of someone who has lived in big cities and much spent time in the ocean wilderness. I have lived in climates ranging from Florida to Calif. to Alaska, and they are all getting hotter. I think I can help educate and motivate people.

#### What is your vision for the Town of Fairfax?

I envision Fairfax to be a leader in sustainable living and climate preservation. It is a beautiful town with many jolly people. As long as we can keep it not too developed, affordable, and diverse, it can be a place where there is good water and air. We owe it to future generations to do what it

takes to enable us to have cool breezes, regular rain, robust forests, and clean and safe parks. This will take some change, but we can figure that out.
