#### RECOMMENDATION

Adopt a resolution designating the Town Manager as its agent for purposes of obtaining certain federal and state financial assistance.

#### DISCUSSION

In order for the Town to obtain certain federal and/or state financial assistance for disasters, the Town must adopt a resolution authorizing the Town Manager to execute the required agreements and assurances for the funding. The resolution must be adopted every 3 years. The previous Fairfax resolution has expired.

The attached resolution was prepared using the template provided by the California Governor's Office of Emergency Services (CalOES).

#### FISCAL IMPACT

Adoption of the resolution will allow the Town to receive federal and state assistance for disasters.

#### A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX DESIGNATING THE TOWN MANAGER AS ITS AGENT FOR PURPOSES OF OBTAINING CERTAIN FEDERAL AND STATE FINANCIAL ASSISTANCE

#### BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF FAIRFAX THAT the

Town Manager or his/her authorized designees, is hereby authorized to execute for and on behalf of the Town of Fairfax, a public entity established under the laws of the State of California, this application and to file it with the California Governor's Office of Emergency Services for the purpose of obtaining certain federal financial assistance under Public Law 93-288 as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, and/or state financial assistance under the California Disaster Assistance Act; and

**BE IT FURTHER RESOLVED THAT** the Town of Fairfax, a public entity established under the laws of the State of California, hereby authorizes its agent(s) to provide to the Governor's Office of Emergency Services for all matters pertaining to such state disaster assistance the assurances and agreements required.

This is a universal resolution and is effective for all open and future disasters up to three (3) years following the date of approval below.
