- CAC could have a presence in the Fairfax Parade on Festival weekend.
- An EV and E-Bike show is hoped for. Ride & Drive Clean would do a lot of the organizing at a cost of \$5000, which could be split between the Fairfax and San Anselmo committees. The Earth Day event in Mill Valley will also have an EV & E-Bike show; if we can attend that it could help with planning.
