SUBJECT: Interview and consider appointment of applicants to the Climate Action

Committee and the Community Emergency Preparedness Committee; appoint a

Council liaison to the Community Emergency Preparedness Committee

RECOMMENDATIONS

1. Interview applicant Liz Gottlieb for the Climate Action Committee to fill a vacancy term to May 31, 2025, and make appointment as appropriate.

- 2. Interview applicants Guy Norenius and Jeremy Nieuwenhuijs for the Community Emergency Preparedness Committee, each for a three-year term, and make appointments as appropriate. Staff recommends Mr. Norenius be appointed to the at-large community member position and Mr. Nieuwenhuijs be appointed to the Neighborhood Response Group category.
- 3. Appoint Mayor Cutrano Town Council liaison on the Community Emergency Preparedness Committee.

DISCUSSION

Climate Action Committee

There are currently three (3) vacancies for the Climate Action Committee, each with a term of two (2) years. There is one applicant for the position, Fairfax resident Liz Gottlieb, who has attended at least one meeting of the Committee.

The Climate Action Committee ("CAC") was established to implement the Climate Action Plan, adopted by the Town Council on February 5, 2014. Its mission is to mitigate the production of greenhouse gas and compile existing and potential strategies to address climate change. Initially it was a subcommittee of the General Plan Implementation Committee ("GPIC"); in July 2015, CAC was established as a separate Town Committee.

CAC develops an annual action plan as well as any recommended amendments to the Climate Action Plan. In addition, the committee keeps a scorecard to track greenhouse gas reduction actions taken.

Community Emergency Preparedness Committee

There are currently two (2) at-large community member vacancies on the Community Emergency Preparedness Committee ("CEPC"). The seven members of the committee are to represent specific stakeholders, according to the CEPC establishment resolution. Additionally, there is one vacancy for the Fairfax Chamber of Commerce category, one for the Neighborhood Response Group ("NRG"). When making appointments, the Council will need to state which stakeholder group the member will represent.

The applications for the CEPC before the Council tonight are from two Fairfax residents:

- Guy Norenius
- Jeremy Nieuwenhuijs

Mr. Norenius is eligible for the community member-at-large position.

Mr. Nieuwenhuijs is eligible for the Community Emergency Response Team ("CERT") category and the NRG category; we recommend appointing him to the NRG category since the CERT category is filled.

As a reminder, on March 1, 2023 the Council appointed the first two members to CEPC, one representing Age Friendly category, and one representing the Firewise category. The Community Emergency Preparedness Committee was formed in 2021 by resolution of the Town Council (attached for background) and includes 7 members. Appointing the two applicants would complete the quorum (4) for this committee, allowing them to determine a meeting cadence and begin gathering.

Finally, the Council needs to assign its own liaison to the Committee. Mayor Cutrano has expressed an interest in this role, as he worked with former Fairfax Councilmember Renée Goddard to develop the CEPC and has a clear understanding of the committee's purpose and structure.

RESOLUTION 21-11

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OFFAIRFAX ESTABLISHING A COMMUNITY EMERGENCY PREPAREDNESS COMMITTEE

WHEREAS the Town Council desires to form a Community Emergency Preparedness Committee (Committee) to support and help coordinate collaborative town-wide efforts to prepare residents to respond to emergencies of all kinds; and

WHEREAS the Town Council will follow its standard practice of interviewing and appointing members to the Committee; consider the ratification of appointments from the Fairfax Chamber of Commerce and Age Friendly Fairfax via the Parks and Recreation Commission; assign a Council representative; and request a liaison from the Ross Valley Fire Department; and

WHEREAS the general focus of the Committee would be on tangible, practical, costeffective actions regarding emergency preparedness that can be implemented at the local level, including but not limited to the following:

- a. increase community awareness about the full spectrum of potential disasters and the need for emergency preparedness;
- b. consolidate, develop, and distribute emergency preparedness information and educational materials;
- c. facilitate communication and coordination between existing emergency preparedness programs;
- d. develop, recommend, and implement new community outreach and education activities;
- e. promote and develop volunteer opportunities to encourage community participation in local efforts, such as Firewise and Neighborhood Response Groups (NRG);
- f. collaborate with other governmental agencies focused on emergency preparedness (via coordination of community presentations and regular preparedness updates from Town Council representatives, Town staff, and other local/regional emergency preparedness personnel).

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Town Council of the Town of Fairfax that the Fairfax Community Emergency Preparedness Committee shall be established as follows:

- 1. The Committee shall consist of one (1) liaison from the Fairfax Town Council, one (1) liaison from the Ross Valley Fire Department (RVFD), and (7) members appointed by the Town Council and representing the following Town stakeholders:
 - a. Community Emergency Response Team (CERT)
 - b. Firewise

- c. Neighborhood Response Group (NRG)
- d. The Fairfax Chamber of Commerce
- e. Age Friendly Fairfax
- f. Community members-at-large (2)
- 2. Each appointed member shall serve for a three-year term, with the initial terms staggered to avoid complete turnover in year three.

The foregoing Resolution was duly passed and adopted at a regular meeting of the Town Council of the Town of Fairfax held in said Town on the 5th day of May 2021, by the following vote, to wit:
