SUBJECT: Interview and consider appointment of an applicant to the

Community Emergency Preparedness Committee

RECOMMENDATION

Interview applicant Christine Aralia for the Community Emergency Preparedness Committee for a three-year term and make appointment as appropriate. Staff recommends the Town Council appoint Christine Aralia to the vacant at-large community member position.

DISCUSSION

The seven members of the committee are to represent specific stakeholders, <u>according to the CEPC establishment resolution</u>. There is currently one (1) at-large community member vacancy remaining on the Community Emergency Preparedness Committee ("CEPC"). Additionally, there is one vacancy for the Fairfax Chamber of Commerce category and one for the Neighborhood Response Group ("NRG"). When making appointments, the Council will need to state which stakeholder group the member will represent.

The Community Emergency Preparedness Committee was <u>formed in 2021 by resolution</u> of the Town Council. Four (4) community members have since been appointed. Voting to appoint Christine Aralia will complete the quorum requirements for this committee, allowing the group to determine a meeting cadence and begin gathering.
