July 14 Attended Community Media Center of Marin (CMCM) Zoom meeting - with a pro bono Financial Advisor, CMCM Executive Director, Board Chair re: change in retirement program for eligible staff. Coler is leading the effort to establish a new, improved retirement program for staff.

July 18, 25, August 1 - Met with Town Manager on Town matters (Agenda setting mtg with Mayor) Marin Wildfire Prevention Authority Board meeting was not held in July.

MCE Clean Energy Board meeting was not held in July.

July 24 - Marin County Mayors & Councilmembers (MCCMC) Legislative Committee -The Committee did not have a quorum, the Chair will send a qualified support letter on SB 272 (Laird) re: sea level rise planning - rationale will be to support funding for local jurisdictions for such and support for regional consolidation of these efforts; the Chair will send a qualified oppose letter on SB 825 re: bikes on sidewalks - rationale is inherently unsafe (and compromises) re: age friendliness of local jurisdictions and removes local control. Other updates – the legislature is on recess until Aug 14, when they return 2 weeks of fiscal committees then 2 weeks of floor amendments/votes. The Budget is essentially complete - AB 102 is the main bill and has been signed by the Governor. SB 423 (Weiner) discussions ongoing for amendments, the bill has "serious momentum" - extends SB 35 provisions another ten years, includes coastal zone (overrides Coastal Commission); SB 584 (Limon) re: labor force housing is now a - year bill. MCCMC LEGISLATIVE COMMITTEE SCOPE OF ADVOCACY: Fiscal Protection: protect city revenues from state Local Control: support legislation that enhances local control of resources to provide services while supporting regional co-operation. Oppose unfunded mandates and preemption of local authority and control of land use Transportation Investment: promote stable transportation finance structure for state and local government. Multimodal, enhancing livable communities Housing/Land use: protect local government land use authority. Oppose punitive housing legislation, and legislation that restricts or reduces local discretion on land use decisions. Other legislation can be recommended to MCCMC at a regular meeting.

July 13 — **Mike McGuire's Town Hall Meeting**. Town Hall meeting in the San Anselmo fire station featuring State Senator Mike McGuire and Fairfax Mayor Chance Cutrano, San Anselmo Mayor Steve Burdo, Marin County Sheriff Jamie Scardina, and Ross Valley Fire Chief Dan Mahoney.

July 21 — Press Conference to Celebrate Marin Transit's \$31.5M Federal Grant to Enhance its Zero Emission Fleet. Marin Transit received the largest grant of this type in all of California. Marin Transit plans to convert its fleet entirely to Battery Electric Buses in order to reach its goal of 100% zero emission by 2040. One of the current fleet of electric buses runs on the #23 route, which serves Fairfax. Speakers included:

Marin Conservation League (MCL) is group of environmentally conscious, scientifically informed individuals who serve as the countywide authority on environmental policy. MCL's committees monitor a broad range of planning and land use decisions county-wide to ensure Marin's ecological values are maintained and restored. Picnic on the Patio is an annual celebration and informal gathering.
