FAIRFAX TOWN COUNCIL NOTICE OF PUBLIC HEARING

Notice is hereby given that on Wednesday, September 6, 2023, at 6:30 p.m. or as soon thereafter as the matter may be heard, the Fairfax Town Council will hold a public hearing on the matter described below at the Fairfax Women's Club, 46 Park Road, Fairfax and on Zoom. For information on how to attend the meeting and how to comment at the hearing, visit the Town website www.townoffairfax.org and select the meeting section on the home page.

Description: Proposed ordinance prohibiting new gas stations and prohibiting expansion of fossil fuel infrastructure at existing gas stations; CEQA categorically exempt; § 15307, § 15308 and § 15061(b)(3).

The agenda, staff reports, and associated materials will be available at least 72 hours prior to the meeting on the Town website at www.townoffairfax.org.

Accommodation: If you need accommodation to attend or participate in this meeting due to a disability, please contact the Town Clerk at (415) 453-1584 a minimum of 48 hours prior to the meeting.

Environmental Review: Exempt from CEQA review in accordance with Sections 15307 and 15308 as action taken by a regulatory agency to protect natural resources and the environment. Pursuant to the "common sense" exemption under CEQA Guidelines section 15061(b)(3), there is no possibility that this ordinance might have a significant effect on the environment. This ordinance will prohibit new gas stations and the expansion of fossil fuel infrastructure at existing gas stations, in turn, limiting future groundwater or surface water contamination, leaks from underground tanks, or improper disposal of gasoline.

Anticipated Actions: The Town Council will hear a staff report, take public testimony, discuss the proposed ordinance and may introduce the ordinance.
